Sir,

With due respect, I am producing herewith one arrested accused person namely Sajal Karmakar (46) S/O Lt. Santosh Karmakar of Porajhar, P.S- NJP, Dist- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 15(Fifteen) bottles of Himalayan 70 up Fata Fati County Spirit containing 300 ml in each bottle.

I, SI-Pradeep Diyali presently attached with NJP PS under your kind control beg to state that today i.e. on 04.03.2023 at 22.10 hrs I received a secret source information that one person namely Sajal Karmakar (46) S/O Lt. Santosh Karmakar of Porajhar, P.S- NJP, Dist- Jalpaiguri is selling ID liquor illegally at his house at Porajhar under NJP P.S. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No: 180 date: 04.03.2023 and informed the fact to you. As per your kind direction and instruction myself along with VP/13 Jamirul Islam, CV/306 Biswajit Roy, CV Niru Kumar yadav all of NJP PS, SPC left for Fu, PS- NJP, Dist- Jalpaiguri to work out the information in hand. At about 22.25 hrs we arrived at Porajhar, under New Jalpaiguri PS, Dist- Jalpaiguri and being identified by the source I held raid the house where the above noted accused person selling ID Liquor. Accordingly as per the indication of Source I managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his house since long for his illegal gain. On search the above noted I/D liquor recovered from his house. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his house. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 22.35 hrs to 23.10 hrs on 04.03.2023

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Sajal Karmakar (46) S/O Lt. Santosh Karmakar of Porajhar, P.S- NJP, Dist- Jalpaiguri and arrange for its investigation.
