In producing herewith one accused person namely Langkeswar Roy (42 yrs), S/O- Lt Bijen Roy Of Maharajghat, PS- NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list.

1. 13 (Thirteen) Bottles of Blu 80 Up country spirit containing 600 ML each.

I SI Proboidh Ch Das of Milanpally out post under NJP PS do here by lodged a written complaint to the effect that today on 06.03.23 at 17.45 hrs acting on a tip-off source information myself along with, C/ 980 Sadhan Barman, VP 12 Dasarath Roy had been to Maharajghat under Milanpally OP to work out the information that a huge number of country spirit are stocked in the Momo Stal of one Langkeswar Roy of Maharajghat, PS- NJP, Dist- Jalpaiguri without license to sale the same in the open market. This refers to Milanpally out post GDE No 138 date 06.03.23. On arrival at Maharajghati at 18.25 hrs and I called two local witnesses to witness the raid and on being identified by the engaged source we held raid in the Momo Stal of Langkeswar Roy and could recover the above noted of liquor. During raid the above noted accused person was arrested from whose exclusive possession the above noted liquors were found. On demand he could not produce any license/documents in support of his possession. On interrogation he admitted that he has been running the business clandestinely since long. Accordingly I seized the above noted liqueur proper seizure list and arrested the accused person U/S - 41 Cr.P.C and took him into the custody. The seizure was made in between 18.45 hrs to 19.25 hrs.

Hence, I pray that a specific case under proper section of law may kindly be initiated against the accused person namely Langkeswar Roy (42 yrs), S/O- Lt Bijen Roy Of Maharajghat, PS- NJP, Dist- Jalpaiguri
