In producing herewith one arrested accused person namely Subash Sarkar(29yrs), S/o. Lt. Santosh Sarkar of Haricharan Vita, PO. Balaram, PS. NJP, Dist-Jalpaiguri along with the following seized articles as per proper seizure list:

1. 18(Eighteen)sealed bottles of Kingfisher Strong beer each bottle containing 650 ML.
2. One Plastic Bag.

I, ASI. Biswajit Ghosh of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted accused person to the effect that today on 06.03.2023 at 18:05 hrs received source information that one person has gathered huge amount of liquor illegally at Sahudangi Hat area for selling the same among the customers for his wrongful gain. Accordingly I shared the information to O/C Ambari Falakata OP and as per his direction myself along with (1) C/975 Swarup Basak, (2)LC-741 Mallika Roy and (3) HG-1158 Niten Roy all are of Ambari-Falakata OP, under NJP PS/SPC left OP to verify the veracity of information. This refers to Ambari-Falakata OP GDE No.207, dated: 06.03.2023. At 18:25 hrs we reached at Sahudangi Hat area, sometimes after being identified by the source our police party held raid at the local area, situated at Sahudangi Hat area and recovered the above noted articles from the possession of accused person namely Subash Sarkar(29yrs), S/o. Lt. Santosh Sarkar of Haricharan Vita, PO. Balaram, PS. NJP, Dist-Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person in presence of witnesses and preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made in between 18:45 hrs to 19:05 hrs. Then I arrested the said noted accused person u/s 41 Cr.P.C. and issued him Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Subash Sarkar(29yrs), S/o. Lt. Santosh Sarkar of Haricharan Vita, PO. Balaram, PS. NJP, Dist-Jalpaiguri under proper section of law.
