Sir,
In producing herewith one arrested accused person namely Biswajit Biswas(25yrs), S/o. Tapan Biswas of Sarada More near Jaleswari, PO. Sahudangi Hat, PS. Bhaktinagar, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 14(Fourteen) sealed bottles of Kingfisher Strong beer each bottle containing 650 ML.
2. One Plastic Bag.

I, ASI. Kajal Chakraborty of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted accused person to the effect that today on 06.03.2023 at 13:58 hrs. myself along with (1) C/824 Satyaban Das and (2)NVF-029 Kiran Roy both of Ambari-Falakata OP, under NJP PS/SPC left OP to perform van duty at Ambari Falakata OP area. This refers to Ambari-Falakata OP GDE No.199, dated: 06.03.2023. During raid duty at 18:25 hrs received source information from Anchal More area under Ambari-Falakata OP that the above noted accused person has gathered huge amount of liquor illegally for selling the same among the customers for his wrongful gain. Immediately I shared the information to O/C Ambari Falakata OP and as per his direction myself along with above noted forces proceeds to Anchal More area to work out the information. At 18:45 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the local area, situated at Anchal More area and recovered the above noted articles from the possession of accused person namely Biswajit Biswas(25yrs), S/o. Tapan Biswas of Sarada More near Jaleswari, PO. Sahudangi Hat, PS. Bhaktinagar, Dist-Jalpaiguri On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person in presence of witnesses and preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made in between 19:05hrs to 19:15 hrs. Then I arrested the said noted accused person u/s 41 Cr.P.C. and issued him Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Biswajit Biswas(25yrs), S/o. Tapan Biswas of Sarada More near Jaleswari, PO. Sahudangi Hat, PS. Bhaktinagar, Dist-Jalpaiguri under proper section of law.
