Sir, In producing herewith the 05 (Five) arrested accused persons namely (i) Raju Das @ Pullak (37) s/o Lt. Jogendra Nath Das of Gosanimari, PS- Dinhata, Dist.- Coochbehar (ii) Sanjay Sarkar (22) s/o Ganesh Chandra Sarkar of Jambari, Gosanimari, PS- Dinhata, Dist.- Coochbehar (iii) Manoj Rabidas s/o Lt. Sibur Rabidas of Chandan Choura, PS- Pundibari, Dist.- Coochbehar (iv) Bhaskar Sah s/o Lt. Paresh Ch. Sah of East Khagrabari, PO- Khagrabari, PS- Pundibari, Dist.- Coochbehar, (v) Sukumar Sah (44) s/o Mukunda Sah of Purba Khagrabari, Natunpally, PS- Pundibari, Dist.- Coochbehar along with the following seized articles under proper seizure list :-

I, SI Pradeep Diyali of New Jalpaiguri Police station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted 05 (Five) arrested accused persons to the effect that today 06.03.2022 at about 1315 hrs I received a specific source input that 05 (Five) persons coming from Coochbehar Side and proceeded towards Kolkata side with one vehicle bearing registration No.- WB/60J/8484 with huge consignment of Ganja for their clandestine disposal. The matter was diarized vide NJP PS GDE No. 251 Dt. 06.03.2023 and I informed the matter to SI Partha Sarathi Das, Officer-In-Charge, New Jalpaiguri Police Station, Siliguri Police Commissionerate in writing a letter to him and expressed the entire information. As per his kind direction myself along with other officers and force named ASI-Khagen Barman, VP/13 Jamirul Islam, CV/306-Biswajit Roy, CV/824 Niru Kumar Yadav all of NJP PS, Siliguri Police Commissionerate being headed by me left for Fulbari Toll Gate, PS-New Jalpaiguri, Dist.- Jalpaiguri by govt. vehicle with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No 252 dated 06.03.2023 and M.C.C. No. 411/2023 dated 06.03.2023. In the mean time I also informed the RT Van Officer ASI Binay Subba of New Jalpaiguri PS, Siliguri Police Commissionerate, to accompany us. Further I also informed the Videographer namely Tapan Mandal s/o Testo Mandal of Bhola More, PS- NJP, Dist.- Jalpaiguri to be present at Fulbari Toll, under New Jalpaiguri PS, Dist.- Jalpaiguri to prepare the Video of whole process of search and seizure if any. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender. At about 1415 hrs we arrived at Fulbari area under New Jalpaiguri PS, Dist.- Jalpaiguri and on the way to the spot, I called two independent witnesses namely Bassu Dev Sarkar

Exhibit 7. Examined and seized articles in presence of Shri Narendra Kalikoty, WBPS, Assistant Commissioner of Police, Special Branch, Siliguri Police Commissionerate and independent witnesses and accused persons as noted above. The whole process of seizure was made in between 1915 hrs to 2045 hrs. On further asked they confessed in presence of Shri Narendra Kalikoty, WBPS, Assistant Commissioner of Police, Special Branch, Siliguri Police Commissionerate acting as Special Executive Magistrate and other witnesses that they procured the Ganja clandestinely from Coochbehar for the purpose of supply the same to their designed customers in Kolkata as per their requirement for their personal gain by illegal means. On interrogation they also disclosed that they have been dealing in such business of selling the brown sugar illegally for last few months.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely (i) Raju Das @ Pullak (37) s/o Lt. Jogendra Nath Das of Gosanimari, PS- Dinhatata, Dist.- Coochbehar (ii) Sanjay Sarkar (22) s/o Ganesh Chandra Sarkar of Jambari, Gosanimari, PS- Dinhatata, Dist.- Coochbehar (iii) Manoj Rabidas s/o Lt. Siburabidas of Chandan Choura, PS- Pundibari, Dist.- Coochbehar (iv) Bhaskar Sah s/o Lt. Paresh Ch. Sah of East Khagrabari, PS- Pundibari, Dist.- Coochbehar, (v) Sukumar Sah (44) s/o Mukunda Sah of Purba Khagrabari, Natunpally, PS- Pundibari, Dist.- Coochbehar (Not verified) is involved in procuring and selling of Ganja illegally and contravening the norms of NDPS Act was established, Then, I arrested the above noted 05 (Five) accused persons after observing all guidelines of Apex court of arrest as well after disclosing the cause of arrest and issued necessary Memo of Arrest. The whole process of seizure, seizure labelled and arrest was made in-between 1915 hrs to 2045 hrs on 06.03.2023.

Under the above noted facts and circumstances, I pray to you that a specific case under the respective sections of law may kindly be started against the above noted arrested lady accused persons namely (i) Raju Das @ Pullak (37) s/o Lt. Jogendra Nath Das of Gosanimari, PS- Dinhatata, Dist.- Coochbehar (ii) Sanjay Sarkar (22) s/o Ganesh Chandra Sarkar of Jambari, Gosanimari, PS- Dinhatata, Dist.- Coochbehar (iii) Manoj Rabidas s/o Lt. Siburabidas of Chandan Choura, PS- Pundibari, Dist.- Coochbehar (iv) Bhaskar Sah s/o Lt. Paresh Ch. Sah of East Khagrabari, PS- Pundibari, Dist.- Coochbehar, (v) Sukumar Sah (44) s/o Mukunda Sah of Purba Khagrabari, Natunpally, PS- Pundibari, Dist.- Coochbehar (Not verified) and others arrange for its investigation.
