address, nearly 13 years back under Muslim rite
& ritual and since after the marriage, my
said husband physically & mentally tortured me
for demand of dowry.

03 (Three) children born out of our wed-lock
and even after that he did not stopped
me subjecting me for physical & mental
cruelty, and did not maintain me & my said children.

On dt. 08/03/2023 at about 11:30 am, he
demanded money from me & when I denied
he started abusing me in filthy languages & beaten
me brutally with fist & blow and threatened me
for dire consequences, if I will not give him Rs.
5,000/- (Rupees Five thousand) as dowry, and when
her mother namely, (1) Rozila Khatun (57) w/o Lt.
Md. Samim (2) and my step-father-in-law namely

(2) Md. Iqbal (80) s/o Lt. Md. Saidul Rahman
protested, he also abused them in filthy languages
and tried to harm himself and also beaten them.

So please take necessary action my said husband.
