Sir with due respect and humble submission, I SI Kamalesh Joardar of New Jalpaiguri Police Station, Siliguri Police Commissionerate would like to submit this complaint to the effect that today on 08.03.2023 at about 18.45 hrs received an information from ASI Nishith Adhikari who was deputed to perform L/O duty at the spot near Bibadi Sangha in c/w Holy festival 2023 that a quarrel was going on at the spot. On reaching there he found that some peoples are creating nuisance over the issue of consuming alcohol. I informed ASI Pradip Sarkar who was detailed for QRT Van for Holy Festival to come at the spot to assist me to prevent any untoward incident as the law and order cannot be ruled out. At 19.25 hrs. ASI Pradip Sarkar arrived at the spot and myself along with ASI Pradip Sarkar and force tried several times to resist the above noted accused person and advised them to go home but they all are in vain and they refused to obey our order, instead they pelted stone against Police team as well as Govt vehicle bearing Regt. No. WB 72 B 0007 and hindrance to discharge public service. As a result Police personnel were injured and Govt. Vehicle has been broken by the said peoples. When they tried to arrest them they fled away from the spot but anyhow the police team managed to apprehend (i) Ujjal Sarkar s/o Lt. Manoranjan Sarkar of Sahid Colony, near Chanachur Factory, Ward No. 34, PS- New Jalpaiguri, Dist.- Jalpaiguri (ii) Kartik Sah (30) s/o Lt. Radha Kishan Sah of Sahid Colony, near Bibadi Sangha, Ward No. 35, PS- New Jalpaiguri, Dist.- Jalpaiguri and others were fled away.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case may kindly be initiated under proper section of law against (i) Ujjal Sarkar s/o Lt. Manoranjan Sarkar of Sahid Colony, near Chanachur Factory, Ward No. 34, PS- New Jalpaiguri, Dist.- Jalpaiguri (ii) Kartik Sah (30) s/o Lt. Radha Kishan Sah of Sahid Colony, near Bibadi Sangha, Ward No. 35, PS- New Jalpaiguri, Dist.- Jalpaiguri (iii) Suraj Sahani and others and arranged for its investigation.
