Respected Sir,

Most humbly I, Navin Rampuria @ Monty, Son of Baijnath Rampuria, resident of Agrasen Road, near Agrasen Bhawan, Ward No. 9 of S.M.C., P.S. Siliguri, Dist. Darjeeling, do hereby inform you that today lodge this written complaint (FIR) to the effect stating today on 09.03.2023 at about 12:45 P.M. at Mangal Pandey Road, I was standing near Mantu Grocery Shop waiting for my friends to meet me at that time Vijay Chowdhury, Son of Late Nand Kishor Chowdhury, resident of Mangal Pandey Road, near Biswakarma Mandir, came in drunken condition and stopped near me and without any provocation started using filthy words and bad language touching Marwari Community and when I protested to such use of filthy language for one community at that time he caught hold of my collar and pulled me as a result I fell down alongwith my motor cycle.

As soon as I fell down the said Vijay Chowdhury started to physically assault me by hands and leg in my chest and also hit me on my head with iron punch resulting in severe on my head. He also attempted to assault me in my neck through broken glass and due to such assault I got cut in my hand. The said Vijay Chowdhury also snatched about Rs. 3,000/- from my pocket and ran away by uttering words that he did this act of physical assault with an intension to kill me as because he believes that I am the hand of the ward councilor and as Vijay Chowdhury has enmity with the councilor (Amit Jain) so he is taking revenge with me to teach him a lesson.

Thereafter with the help of local people I was brought to District Hospital Siliguri for treatment and I am still under the treatment of the doctor.

Hence I lodge this FIR against Vijay Chowdhury for taking necessary legal action.
