1. That today at around 7-00 pm a person named Sri Raja Sarkar S/o Lt. Subhas Sarkar, resident of Babupara, Siliguri, Ward no. 27 forcefully entered into my shop and tried to rob and break my cash box and extort money in the name of Gunda Tax and in the process physically assaulted my staff Sri Pintu Singh and tore his clothes and tried to rob and damage my shop materials.
2. That my staff immediately informed me about the same and I arrived quickly after informing the duty officer over Phone.
3. That seeing me the accused Sri Raja Sarkar threatened to murder me later on.

4. That my shop is located just opposite to Siliguri Police Station and still such criminals are brave and so audacious to commit such kind of crime right under the nose of police, which makes us feel lack of security.
5. That even in side Police station the accused threatened to murder me and my staff after being released.
6. That in this situation I request you to take proper action and necessary steps to ensure our security and help us to get proper justice.
