Respected Sir,

I MD. Basir Alam @ Milan, S/o Abdul Rab Mushi, residing at Hemanta Basu Colony Ward No. 4, P.O & P.S. Siliguri, Dist. Darjeeling, would like to inform you that today i.e. on 10/03/2023 at about 8.00 pm some persons of our locality namely 1) Md. Dhulal, S/o not Known, 2) Md. Bhuchun @ Afijul, S/o not Known, 3) Md. Anarul, S/o not Known, without any reasons all of them came in front of madrasa with drunk condition and after came there they started to use slang languages in respect of me and when I tried to protest the same at that time all of them started to threaten me with dire consequences and after listening their shouting my wife namely Rinki Roy, my brother namely Manjur Alam and also my mother Namely Manoara Begum came to the spot and tried to rescue me from their hands at that time they called their associates namely Hali Begum, W/o. Md. Dulal, Gulabsa Khatoon, W/o. Md. Anarul, Fatema Khatoon, D/o. Md. Dulal, Md. Toshid, S/o. Md. Bhuchun @ Afijul, all of them are reside of our same locality and after that they all of them with the intention to kill us they started to assault me and my above noted family members with the help of lathi and iron rod as a result of which I and my above noted family members sustained multiple injuries on our whole body and specially me and my brother sustained head injury and with the help of local people we took at siliguri Sadar Hospital and treated there and it is also important to mention here that the above noted persons at the time of said incident they intentionally outraged the modesty of my mother and my wife in presence of local people and they also threatened us and told us that if we lodge any complaint before any authority then they will come again and kill us for that reasons I as well as my family members spend our time in fear.

So, no other alternative way today I knock your door against them.

Therefore, I request you be pleased to draw your kind attention and take necessary legal actions against them as early as possible.
