I, Sri Vijay Kumar Shah, son of Late Dindayal Shah, Indian by Nationality, Hindu by Religion, Business by occupation, resident of Elina Residency, Shaktigarh Road No. 01, P.O. Siliguri Bazar, P.S. Siliguri, Dist. Darjeeling – 734005 in the State of West Bengal would like to bring into your kind information the following facts:

1. That I had purchased for valuable consideration and thus became the lawful owner of all that piece and parcel of land measuring 2 Katha 11 Chattak and 30 Sq. Ft. having actual and khas possession of the said land, appertaining to forming part of R.S. Plot No. 2143, recorded in R.S. Khatian No. 180/1 of Mouza–Siliguri, in the District of Darjeeling by virtue of Deed of Conveyance executed by Sri Deepak Kumar Agarwal, Sri Mahesh Kumar Agarwal and Smt. Deoki Debi Agarwal and registered at the office of the Additional District Sub- Registrar Siliguri and recorded in Book No. I, Being Document No. 1386 for the year 2018 and thereby acquired the said land having permanent, heritable and transferable right, title, interest and possession therein, free from all encumbrances and charges.
2. That the following persons along-with their 7-8 associates equipped with Lathi's, Iron Rods and hammer made a very forceful attempt to grab a portion of my land (*together with structure standing thereon*) more described in the schedule below by ousting me therefrom:
 - a. **SMT. NISHA SUBBA**, D/o. Mantu Chandra Das, resident of 181/9, Kishan Garh, A-11 Vasant Apartment, Vasant Kunj, S.O., South West Delhi, Delhi – 110070
 - b. **SHRI BIKASH SAH** S/o Lalan Sah, resident of Ganganagar, Ward No 5, Siliguri - 734005
3. That they are very desperate to take the possession of my below mentioned scheduled land. On 10.03.2023 at about 11:30 AM, they have vandalized a portion of the boundary wall of the said plot of the land to make their entry into my premises. When the caretaker of my land Shri Bajrang Lal Agarwal, S/o. Late Pokermal Agarwal, resident of Burdwan Road Near Golden Plaza, Siliguri – 734005, Dist. Darjeeling tried to obstruct them, the said land grabbers threatened my caretaker Shri Bajrang Lal Agarwal and labourers to stop the work and leave the place. They also made a demand of a ransom of Rs. 2,00,000/- (Rupees Two Lakh) only else they shall not hesitate to shed blood to establish their possession over our below scheduled land.
4. That when my caretaker obstructed them, they slapped him and knocked him to the ground. They snatched his ornamental chain made of gold costing approximately Rs. 32,500/- and his purse containing money amounting to Rs. 3,200/.

5. When all our workmen protested their illegal attempt, they stopped further demolition of boundary wall and returned back but while returning back, they with the help of their associates took away my following building materials with them, the list of materials looted by them is as follows:

- a. 4 Pole MCB – Havells (63A) – 1 Nos
- b. TCP MCB Havells (32A) – 4 Nos
- c. DHGCSPF016 Havells (16A) MCB – 2 Nos
- d. 32 SqMM x 3.5C AL AR Cable (KEI) – 110 Mtrs
- e. 95 SqMM x 3.5C AL AR Cable (KEI) – 25 Mtrs

The Value of the above – mentioned materials is Rs. 40,472/-.

6. That my caretaker and labourers are afraid of such aggression, and feeling unsafe in my premises.

Sir, the accused have committed grave offences under various provisions of IPC and other statutes of our law of the land. They need to be immediately restrained with utmost priority to avoid further loss of property and human life and for installing public peace, communal harmony and tranquility in and around the locality.

In the present facts and circumstances, it is submitted that I along-with my workmen find ourselves absolutely helpless and approach you without delay and request you to investigate into the matter and ensure the safety of my employees and construction materials stored in my premises.




