Respected Sir,

I **Rubi Khatun**, Wife of Md. Rujban, Resident of Jorapakaru, Binnaguri, Kamarbhita, P.O. & P.S. New Jalpaiguri, District - Jalpaiguri, (W.B.). Pin - 735135, do hereby like to inform you as follows :-

1. That my husband is a driver by profession and ply one City Auto bearing no. WB73F6888 for earning our livelihood. I heard on 07.03.2023 one accident took place with the said City Auto at Deniagara and one person was injured namely Johor Sarkar and subsequently he died.

2. That on 07.03.2023 at about 8.30 P.M. when I was in my house with my 5 (Five) children 1. Rehmati Khatun, (Age - 15 years), 2. Mehek Khatun (Age- 12 years), 3. Jannati Khatun (Age - 9 years), 4. Md. Faizal (Age - 8 years), 5. Md. Azan (Age - 6 years). At that time one of my neighbor namely Md. Niyaz suddenly came to my house and told me to vacate the house immediately with my children as because he had information that some antisocial persons may any time attack my house. Subsequently I went to the house of my sister in law namely Hamida Khatun.

3. That at about 9 P.M. when I was on my way towards the house of my sister in law at that time some antisocial persons namely **1. Tubai Sarkar**, Son of Johar Sarkar, **2. Tukun Sarkar**, son of Johor Sarkar, **3. Raja Sarkar**, son of Johar Sarkar, **4. Shyamal Roy**, Son of Not Known, all around 50 persons in a mob along with lathi, vajali, sword and other dangerous weapon suddenly attacked my house and broke our main door and tin boundary and also started to destroy all the articles and belongings in the house. The above named persons also throw all the cloths, utensils and other household articles of the house. Hearing this I immediately returned to my house and saw that the above named persons were intoxicated along with all dangerous weapon furiously and aggressively throwing the entire household articles from the house. Seeing this I was in fear of my life could not resist them from their wrongful acts.

4. That the above named persons also broke one showcase, fridge, ceiling fan, T.V., Stand fan, home theater etc. The above named persons also looted my house by breaking the locker in the showcase and took 1 Lakh rupees cash, which I took as a loan from Bandhan Bank, one Gold earring weight about 6 Gram. The above named persons also broke all the other costly household articles in the house. The above named antisocial persons thereafter spread kerosin oil in the house and put fire in my house, at this I rushed towards my house and somehow succeed to set off the fire. At this when I tried to resist them from breaking my house, then they got furious and pushed me forcefully by touring my cloths and also tried to kill me, at this local people started to gather and local police came to the spot and the above named persons fled away. Subsequently some people came and rescue me from the above antisocial persons and gave us necessary medical assistance.

5. That the above named accused persons also threatened me that they will again come to my house put kerosin oil in my house and set fire. Moreover they also threatened me that they are above the Law and if I try to take any legal action against them then they will kill me and my children and destroy my house and will defame me and destroy my reputation.

Therefore under the above mentioned circumstances I request before your good self to kindly look into the matter and take necessary action against the aforesaid persons as per the provision of law, otherwise my legal rights will be in jeopardy and for this act of kindness I shall remain extremely grateful to you.
