Sir,

I, ASI Khagen Barman presently attached with NJP PS under your kind control beg to state that today i.e. on 11.03.2023 at 2155 hrs I received a secret source information that one Blue Color Tractor displaying registration No.-WB/73 TC/164 mining sand outside the lease area Mahananda River, Right Northern side of Mahananda Bridge No.-04, PS-New Jalpaiguri PS, Dist.- Jalpaiguri for its clandestine disposal. Accordingly I diarised the fact in the General Diary vide New Jalpaiguri PS GDE No.- 510 date:11.03.2023 and also informed the matter to Officer-In-Charge, New Jalpaiguri PS, Siliguri Police Commissionerate. As per kind direction and instruction of Officer-In-Charge, New Jalpaiguri PS, Siliguri Police Commissionerate myself along with force namely VP/08 Laxman Roy, CV/116 Rohit Kumar Mahato, IIG/794 Ranjit Roy all of NJP PS, SPC left for Mahananda River, Northern side of Mahananda Bridge No.- 04, PS- NJP, Dist.- Jalpaiguri to verify the verisity of the information. At about 2215 hrs myself along with Officer & force arrived at Mahananda River, Northern side of Mahananda Bridge No.- 04, under New Jalpaiguri PS, SPC. At about 2035 hrs we saw one Blue Color Tractor loading Sand in the Blue Color Tractor displaying registration No.-WB/73 TC/164 by his driver outside the lease area of Jal Maa Ghat. We held raid at Mahananda River, Northern side of Mahananda River, after seeing the Police Team, the driver of the tractor displaying No. Plate.-WB/73 TC/164 fled away from the spot. That there is sufficient reason to belive that the above noted Driver have stolen those sand from Mahananda River without any Legal Royalty/Paper as per rules, for selling the same Clandestinely. Accordingly, I seized the said Blue Tractor bearing registration No.- WB/73 TC/164 loaded with sand after preparing proper Seizure list in an abandoned condition left by the driver of the Tractor. The whole process of search & seizure was made in between 2245 to 2315 hrs on 11.03.2023..

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the the driver of the Blue Color Tractor displaying registration No.-WB/73 TC/164 and its owners and arrange for its investigation.
