Respected Sir,

- I, **SMT. BINA DAS**, Wife of Sri Dipak Das, residing at Mahananda Ghat Road, Bhupendra Nagar, Ward No.42 of S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, Pin- 734008, do hereby lodge a complaint against 1) Nityananda Barman, Son of not known, 2) Smt. Sampa Barman, Wife of Sri Nityananda Barman, 3) Bikky Barman, Son of Nityananda Barman and 4) Manisha Barman, Daughter of Sampa Barman, all are residing at Mahananda Ghat Road, Bhupendra Nagar, Ward No.42 of S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, Pin- 734008 to the effect as follows:-
- 1) That I am owner-in-possession of land measuring 2 Kathas, recorded in Khatian No.83/1, comprised in Plot No.30/227, under Sheet No.5, within Pargana- Baikunthapur, under Mouza- Dabgram, B.L.&L.R.O., Rajganj, P.S. Bhaktinagar, Dist. Jalpaiguri, by virtue of a registered Deed of Sale, vide No.I-828, dated- 30-03-2009, registered in the office of the D.S.R., Jalpaiguri and thereafter I constructed a single storied residential building in and over the said land with my hard earned money and availing loan from private financial company by mortgaging the said landed property with the company and the original Sale Deed is lying with the said company and obtained holding vide No.1901/6/11 in my name from the S.M.C. in respect of the said property.
- 2) That I reside with my husband at the said house standing on the said land but due to the fiduciary relationship with the above-named persons permitted them to stay/reside into my aforesaid house without charging any money.
- 3) That the above-named persons forced, demanded and pressured me and my husband to transfer the said house and land, by executing and registering the gift deed in their names but when along with my husband refused to fulfill their unlawful demand, they had been regularly quarrelling and abusing us in filthy languages and threatening us to quit and vacate the house and land and also threatening us of causing grievous injuries and of dire consequences and they had made our lives miserable and horrible due to the

continuous threat and intimidation causing mental and torture amounting to mental pain and agony.

- 4) That on 20-10-2022, said Nityananda Barman with aid and abetment of other abovenamed persons consuming alcohol abused, humiliated, insulted and dishonoured me and my husband and threatened to murder us holding a dagger in his hand if we do not transfer and register the said property or deliver the possession of the same to them.
- 5) That finding no other alternative way, on 11-11-2022, I filed a case being Petition Case No.939/2022 before the Sub-Divisional Magistrate, Jalpaiguri against said Nityananda Barman and said Sampa Barman and on 27-12-2022 after hearing me and the said persons and perusing the all the relevant documents, the Ld. SDM was pleased to direct the said persons to behave with me in such a manner so that I may live peacefully.
- 6) That despite the said order, dated-27-12-2022, the above-named persons have been continuously abusing me and my husband in most filthy languages and threatening of dire consequences if I do not execute and register the said land and house to abovenamed persons.
- 7) That on 10-03-2023 at about 10:30 pm, the above-named persons in order to commit extortion, put and attempted me and my husband in fear of death and grievous hurt by dishonestly inducing us to sign on some papers for the purpose of execution and registration and to deliver the said house and landed property to them which may be converted into a valuable security but due to hue and cry raised by us, my daughter namely, Rakhi Singh (Das) and my son-in-law, Hira Singh rescued us from them.
- 8) That the above-named persons are very desperate and dangerous persons having no regard about the law of the land and they will translate said threat of death and grievous hurt to fulfill their ill motive and wild mission.

So, therefore, I humbly request your goodself to take appropriate legal action against the above named persons and booked them under appropriate provision of law.

I shall remain ever grateful for the needful and be obliged thereby.
