This is to inform you that today i.e. on 14.03.2023 around 13:15 hrs while I was returning from Hill Cart Road from Mukherjee Hospital one person named Shresta Shyam aged around 28 years riding a Bike bearing Registration Number WB 74 BL 7010 with pillion rider Himanshu Tiwari aged around 22 years in front of my car bearing registration no. WB 74 BH 4947 suddenly stopped my car and stated that I have dashed his bike. But in fact there was no incident of dashing. The person named Shresta Shyam who was driving the bike stopped my car and physically assaulted me with filthy language. He pressed my neck and caused injury to me in person. Being a responsible person of the society I demand stringent legal action against the above stated person as per law as his activity tarnished my prestige and dignity.
