Sir,

In producing herewith one arrested accused person namely Sandip Pradhan (M/30 Yrs), S/O - Shiv Chandra Pradhan, of - Gumti T.E, PO - Mahanadi, PS - Kurseong, Dist - Darjeeling along with one seized vehicle (Bolero Pik Up) bearing registration no WB 73 D / 3073 loaded with river bed materials.

I ASI Prem Bhakta Mallick of NBMC OP Under Matigara PS beg to lodge a written complaint against the driver of the above mentioned vehicle named Sandip Pradhan and the owner of the vehicle bearing registration no WB 73 D / 3073 to the effect that today i.e 14.03.2023 at 20.15 hrs in course of evening van duty vide GDE No 382 dated 14.03.2023 I along with C/ 1071 Sumit Sherpa & CV - 158 Partha Sarkar reached at Nimtalaghat of Balason river under Matigara PS, Dist - Darjeeling and found that some persons were loading river bed materials in Bolero Pik Up Van bearing registration no WB 73 D / 3073 the Pik Up Van have in the beside of the rivers of Balason under Darjeeling District, seeing the police van the driver of Pik Up Van and others are trying to fled away from the spot, but we managed to intercept the above noted vehicle and apprehended above noted person. On interrogation, accused person disclosed his name and identity as Sandip Pradhan (M/30 Yrs), S/O - Shiv Chandra Pradhan, of - Gumti T.E, PO - Mahanadi, PS - Kurseong, Dist - Darjeeling and confessed that he along with others were stealing the river bed materials from the river of Balason at Nimtalaghat under Matigara PS, Dist - Darjeeling for selling clandestinely and the accused person failed to produce any document for possessing the river bed materials and he also stated that as per direction of owner of the Pik Up van bearing registration no WB 73 D / 3073 he stolen the river bed materials from Nimtala Ghat under Matigara PS, Dist - Darjeeling. There is sufficient reason to believe that the above noted vehicle driver have stolen river bed materials from the river of Balason at Nimtalaghat under Matigara PS, Dist - Darjeeling for selling clandestinely. Accordingly, I seized the vehicles (Bolero Pik Up) bearing registration no WB 73 D / 3073 truck loaded with river bed materials under proper seizure list and arrest the above noted person U/S 41 Cr.P.C informing him the ground of arrest after issuing Memo of arrest. The search, seizure and arrest were made in between 21.15 hrs and 21.35 hrs on 14.03.2023.

Under this circumstance I pray before you a specific case against the above noted accused person namely Sandip Pradhan (M/30 Yrs), S/O - Shiv Chandra Pradhan, of - Gumti T.E, PO - Mahanadi, PS - Kurseong, Dist - Darjeeling and owner of the vehicle bearing registration no WB 73 D / 3073 may kindly be started and arrange for its investigation.
