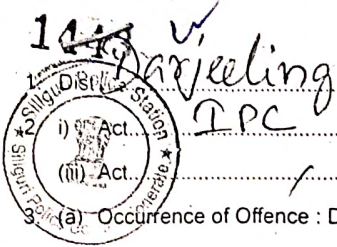

In producing herewith 05 (five) arrested accused persons namely i) Pankaj Talukder 24yrs s/o Pradip Talukder r/o Dakhin Bhanga More PO, Sikarpur PS, Mathabanga Dist, Coochbehar A/P Durganagar Ward No 40 PS, Bhaktinagar Dist, Jalpaiguri ii) Goutam Biswas 30yrs s/o Amar Biswas of Santinagar Bau Bazar PO, Dabgram PS, Bhaktinagar Dist, Jalpaiguri iii) Swapan Roy 22yrs s/o Dinesh ARoy of Ektiasal Hat Pradhanmore PS, Bhaktinagar Dist, Jalpaiguri iv) Palash Mandal 28yrs s/o Pujan Mondal r/o Ramsai Barahati more PS, Maynaguri Dist, Jalpaiguri A/P C/o Kalu Paul Subash Pally Bazar PO, Dabgram W-No 23 PS, Siliguri Dist, Darjeeling v) Ratan Debnath 44yrs s/o Late Nonigopal Debnath of Janata Nagar PO, Sevok road PS, Bhaktinagar Dist, Jalpaiguri along with the following seized articles viz,

I SI Uday Sankar Mandal would like to inform you that today ie on 15.03.2023 in course of morning mobile van duty under Panitanki TOP-I area at around 09.45 hrs received a secret reliable source information that the following four miscreants namely - i) Pankaj Talukder ii) Goutam Biswas iii) Swapan Roy iv) Palash Mandal were assembled Army parking ground at Sevok road with huge quantity of stolen scrap articles (Drain's outside cover Iron Made) if come immediate they can apprehended. I consult with OC Panitanki TOP-I and as per his kind direction I along with available officer and force had been to the Army parking ground at Sevok road seeing the police team the following four numbers of miscreants are tried to flee away from the spot a hot chase somehow I along with my police team had managed to apprehended them along with the following stolen articles ie Drain's outside cover Iron Made. On interrogation they admitted their name and address as mentioned above without produce any Identity. On repeated interrogation they four i) Pankaj Talukder ii) Goutam Biswas iii) Swapan Roy iv) Palash Mandal confessed that for the purpose of their wrongful earn they commit such type of crime since long. On demand they four i) Pankaj Talukder ii) Goutam Biswas iii) Swapan Roy iv) Palash Mandal failed to produce and documents on support of their possessing of huge quantity of Iron Made Drain's outside cover. On repeated interrogation the four miscreants admitted that after stolen the said Iron Made Drain's outside cover from various areas under Siliguri Police Station area and thereafter they sold out the same their one designated customer Ratan Debnath Janata nagar opp, Sevok road Post office under PS, Bhaktinagar. As per the leading statement of above noted four miscreants we further held raid at Janata Nagar on scrap shop styled as Ratan Scrap and recovered the above noted stolen articles mention in SI No ii) to iv) which were he purchased from them previously. On interrogation the scrap shop owner Ratan Debnath admitted his guilt. Hence I arrested all the five miscreants under section 41 CrPC, issued M/A and inform their ground of arrest, also seized all the stolen articles individually seizure list. The seizure was made of article no SI No- I seized in between 10.15 hrs to 10.30 hrs and arrest made accd, SI no i) to iv) upto 10.40 hrs. SI No - ii) to iv) seizure made between 11.05 to 11.30 hrs and accd, si no v) arrest made 11.32 hrs. also mentioned that accd, SI No -i) to iv) during the time of apprehension seeing the police team they fled away to run away from the spot and fell down on the paka road and accd, si no - I got injuries on his persons.


Note: On 06.03.2023 and 11.03.2023 two letter received from the Commissioner Siliguri Municipal Corporation through the superiors where the Ld Commissioner SMC, alleged that during the night time some miscreants were stolen away Iron Made drains outer cover from various ward area in a daily basis.

Under the above noted fact and circumstances, I pray to before your kind honor that a specific case under proper section of law may kindly be registered against the above noted 05(five) arrested accused persons i) Pankaj Talukder 24yrs s/o Pradip Talukder r/o Dakhin Bhanga More PO, Sikarpur PS, Mathabanga Dist, Coochbehar A/P Durganagar Ward No 40 PS, Bhaktinagar Dist, Jalpaiguri ii) Goutam Biswas 30yrs s/o Amar Biswas of Santinagar Bau Bazar PO, Dabgram PS, Bhaktinagar Dist, Jalpaiguri iii) Swapan Roy 22yrs s/o Dinesh ARoy of Ektiasal Hat Pradhanmore PS, Bhaktinagar Dist, Jalpaiguri iv) Palash Mandal 28yrs s/o Pujan Mondal r/o Ramsai Barahati more PS, Maynaguri Dist, Jalpaiguri A/P C/o Kalu Paul Subash Pally Bazar PO, Dabgram W-No 23 PS, Siliguri Dist, Darjeeling v) Ratan Debnath 44yrs s/o Late Nonigopal Debnath of Janata Nagar PO, Sevok road PS, Bhaktinagar Dist, Jalpaiguri under proper section of law and arrange for its investigation.


