Sir,

I, Smt. Usha Chhetri, wife of Late Shanta Kumar Chhetri, Presently Resident of Khopalashi, P.O. New Chamta, P.S. Matigara, District Darjeeling, lodging this F.I.R on the following effects with the request for taking immediate action:-

1. That I am the owner of a plot of landed property, measuring about 0.083 acres or 5 Katha of land, situated within the Mauza: Khopalashi, under L.R. Khatian No.: 1014, L.F. Plot No.: 439, under the jurisdiction of Matigara Police Station, District Darjeeling, vide a Deed of Conveyance being No: 4397 for the year 2006. It is not out of place to mention here that my sister named by Sangita Chhetri, wife of Pushpa Nath Chhetri of Khopalashi, P.O. New Chamta, P.S. Matigara, District Darjeeling is also an absolute owner of a landed property measuring about 0.083 acres or 5 Katha of land, situated within the Mauza: Khopalashi, under L.R. Khatian No.: 1028, L.R. Plot No.: 439, under the jurisdiction of Matigara Police Station, District Darjeeling vide a Deed of Conveyance being No: 4396 for the year 2006 and my daughter named by Sushma Dahal, Wife of Hari Prasad Dahal, is also an absolute owner of landed property measuring about 0.099 acres or 6 Katha of land, situated within the Mauza: Khopalashi, under L.R. Khatian No.: 1036, L.R. Plot No.: 439, under the jurisdiction of Matigara Police Station, District Darjeeling vide a Deed of Conveyance being No: 4435 for the year 2006 and since the date of purchase we are enjoying the physical possession of the above mentioned landed property.

2. That on 04-01-2023 some local people were tried to encroach our above mentioned landed property by demolishing my Bamboo Hut which I had constructed for erecting the boundary walls in our property and for that reason I lodged one F.I.R. before Matigara Police Station on 05-01-2023 but no fruit full result has been came out. It is pertinent to mention here that yesterday again some land mafia namely, 1) Md Jahid; Son of Md Zamaluddin of T.C.P., Zal. Basty, Post Office: Nemai, Police Station:



Matigara, District: Darjeeling, 2) Md. Tahidul @ Master, Son of Md. Asharu, of Panchelguri, Post Office: Nema, Police Station: Matigara, District: Darjeeling, and 3) Bandana Chhetri, Daughter of Unknown, of Panchelguri, Post Office: Nema, Police Station: Matigara, District: Darjeeling and other unknown land mafias came to our landed property and tried to encroach the above referred landed property and with the help of the local people and well wishers I somehow manage to restrain them and raised objection against their illegal act. At that time those above named persons claimed that the landed property belongs to them but fails to produce any document. At that time I asked them for what reason they have come to our landed property and they told that as per the instruction of one Rajen Chettri, Son of Unknown, of Panchelguri, Post Office: Nema, Police Station: Matigara, District: Darjeeling they have come to disturb our peaceful possession and also abused me with filthy languages and also told me that I had to vacate my landed property, failing which I should be in trouble but by the intervention of the local people those miscreants left my scheduled landed property with a threat that they would take the physical possession of my landed property & no one could stop them. Being afraid of their physical power, I am approaching you to take adequate legal action, arresting the above named miscreants and to do the needful in accordance with law so as to protect me as well as my property in no time.

Sir, being helpless law abiding lady, I am Praying before you to take appropriate legal action against those miscreants and to save me and my family as well as my landed property.
