Respected Sir,

I, Omprakash Thakur, S/o Late Kedar Nath Thakur resident of Sukna T.E. Gulma, Salbari, Sukna, Darjeeling, West Bengal 734009 would like inform you as follows: -

1. That today on 16/03/2023 at around 1pm, my daughter namely Janki Thakur who was reading in class 11 at Ila Pal Chowdhary Memorial Tribal High School, left from our home situated at sukna tea estate, Salbari, P.S Pradhan Nagar Dist Darjeeling in order to give her exam along with her two friends.
2. That all of a certain I was informed by my staff working in my saloon that my daughter has been seriously injured by a toto near salbari wine shop.
3. That hurriedly when I, rushed to the spot I, witnessed that a toto had turned upside down, along with few heavy big Plywood used for construction of furniture's and a big paint bucket and my daughter was beneath the materials and the toto and its driver was caught by the locals present at the spot.
4. That my daughter was carried by locals into the ambulance from the spot and my younger brother namely Nagendra Thakur went with the ambulance.
5. That later I, was informed by my younger brother that my daughter was declared brought dead in the hospital namely North Bengal Medica at Pradhan Nagar.

Therefore, I request you to register my complaint against toto driver for causing the death of my daughter which could be avoided if the driver was not negligent enough to carry such heavy materials in his toto and I request you to take necessary action against the shop keeper who caused the said toto to carry such materials so that such incident could be avoided in future with any other person.
