**Subject: FIR**

Sir,

In producing herewith three (03) arrested accused persons namely (i) Sandesh Gurung (30), S/O- Mantap Gurung of Simlay, Raonglit PS, Dist. Darjeeling (ii) Kamakhya Majumdar (36) s/o Lt. Gopal Majumdar of 45/5 Baghajatin Colony, Ward No. 02, PS Pradhan Nagar, Dist. Darjeeling (iii) Suraj Mangar (42) s/o Lt. Krishna Kumar Mangar of Gurung Busty more, Ward No. 03, PS Pradhan Nagar, Dist. Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made sword measuring 33 inch (approx) including butt from the possession of Sandesh Gurung which was kept concealed on his back side.
- (2) One iron made sword measuring 20 inch (approx) including wooden butt from the possession of Kamakhya Majumdar which was kept concealed on his back side.
- (3) One iron made sword measuring 22 inch (approx) including wooden butt from the possession of Suraj Mangar which was kept concealed on his back side.
- (4) Three torch light found from the place of occurrence,
- (5) Two long iron measuring 26 inch (approx) and 30 inch (approx) in length found from the place of occurrence.

I, SI Abhishek Theengh, S/O- Suchandra Kumar Theengh of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Sandesh Gurung, ii) Kamakhya Majumdar, iii) Suraj Mangar and others to the effect that today on 17.03.2022 at 12.15 hrs received a sources information that 12/13 youths have assembled below Mahananda bridge under Pradhan Nagar PS with a view to commit dacoity in a house at Gurung busty bazaar area. The fact was diarized in GD vide Pradhan Nagar PS GDE No-928, dated 17.03.2023. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI- Ashit Singh, CV/242 Rakesh Mangar, CV/992 Jagadish Biswas and CV/646 Baban Das left for the place to work out the information. At about 12.45 hrs after reaching below Mahananda bridge under PS- Pradhan Nagar, I met my source and being pointed by the source we started walking towards back side of the bridge and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on a hot chase we managed to apprehend above noted three (03) accused persons along with seized articles as mentioned above. However, the other persons managed to fled away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Gurung Busty bazaar area.

I thereafter, seized the above noted weapons under proper seizure list and labeled duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.15 hrs to 01.55 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Pradhan Nagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house of Gurung Busty bazaar area. It has been also revealed from them that Rahul @ Daku, Guddu, Nima and some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz (i) Sandesh Gurung (30), S/O- Mantap Gurung of Simlay, Raonglit PS, Dist. Darjeeling (ii) Kamakhya Majumdar (36) s/o Lt. Gopal Majumdar of 45/5 Baghajatin Colony, Ward No. 02, PS Pradhan Nagar, Dist. Darjeeling (iii) Suraj Mangar (42) s/o Lt. Krishna Kumar Mangar of Gurung Busty more, Ward No. 03, PS Pradhan Nagar, Dist. Darjeeling, Rahul @ Daku, Guddu, Nima and others and others and arrange for its investigation.
