This is to inform that I Kamaljeet Singh Chugh, S/O, Waziyam Singh, resident of, "PARUATI NIWAS, 27, Jannunulal Bajar road, Khalbasa, Ward No. 9 - Siliguri-5, when I opened our Shop LABH SINGH EMPORIUM, New, Cinema Road, Malabirstar, (near Sarkar mersay) Siliguri-4, on date: 14/3/2023 morning 10.30am, I found, the ceiling broken (2' x 2') from two points, the Cash Counter was all ransacked, files, paper were all scattered. The cash book, several papers were set on fire by the miscreants in a box like seat.

As per our records the amount of cash stolen from cash box is ₹11,400/- approx, the furniture & fixtures damaged is around ₹14,500/- approx, the stolen goods of suitings and sarees is ₹20,000/- approx.
