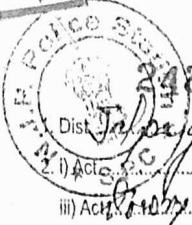

Sir,

With due respect I Smt. Maya Mandal, D/o Gupin Chand Mandal, W/o Sudip Das, presently residing at House No: - 186, Ward No:- 31, Saktigarh, Road No: 4, Near Saktigarh, Pathagar Club, Siliguri - 734005 would like to draw your kind attention to the following effect that on 21.11.2021 our marriage was solemnized as per the Hindu Rites and Customs in the presence of well wishers, family members, Relatives and Friends of both the parties in the above mentioned address that is within the jurisdiction of this Police Station. It is pertinent to mention that before the solemnization of marriage on 21.11.2021 at the above mentioned address [where the marriage was solemnized] a lot of difficulties was been faced by me and my parents regarding the issue of Dowry/Gift and the said issues went to a verge of cancellation due to non fulfillment of desires, the demand from the parents of Groom's side i.e., demand of hand cash, certain gold ornaments and other items like Rs: 4, 00,000/- along with 10 [Vhori] of gold, Bike and fully furnished furniture, but my parents were against the concept of Dowry Pratha, and it was also been supported by the then Groom Now my Husband "Sudip Das" and he said that he will be getting married without taking a single penny neither from me neither from my family. But after the said marriage when I first visited to my Matrimonial house, I came to the notice and ill intentions which were imbedded in my husband and his parents mind, soon after few days of residence in the matrimonial house quarrel between me and the In- Laws started without any rhyme or reason, the situation of mine in the said matrimonial house was so pathetic that my mother in law used to neglect me and didn't provide proper food and inflicted tremendous mental torture upon me saying that "VIKHARI BACHHA JAR BABA BHIKKA KORE BIYE DEI, TAR MEYE KEH BASHI POCHA KHEYE BACHTEA HOBE, NAHOLE GOLAY DORIE DEY MOREA JAA, AMAR CHELER MOTHY BHOROM HOYE CHILO, TAR JONNO KONO PON NAH NIYEA BIYE KORLO, PETHANI - SAKHCHINIE KOTH KAR" as a result I became ill and ultimately my father was called for the same and at that point of time I was drove out by my husband and his uncle named Balaram Das and whereby they also insulted my father. However, my father along with my aunty on 15.12.2021 again took to my matrimonial house to keep me and also to save the matrimonial tie but at point of time the in laws and the uncle Balaram Das asked Rs: 5,00,000/- as a dowry otherwise they will not accept me but somehow my parents managed to keep me in my matrimonial house but after my inception in the matrimonial house the Mother and Father In Law again started to torture me with Filthy languages, no proper and adequate food for my survival, but the matter went beyond the permissive control as the Mother and Father In Law started physically abusing me and also brought blank white sheet with a pen and forced me

to write therein that I will voluntarily leave my matrimonial house at that point of time I fled from their Grip with a plea to spit in outside and took shelter in my parental house and again on 21.04.2022 I entered into her matrimonial house but after 2 months the same story and dispute was going on with me and ultimately in the month of July 2022 the Mother and Father In Law along with my husband confined me in a room without providing any sort of food as a result I became sense less and was admitted in a hospital and from there I was shifted to my parental house. Thereafter I again entered in my matrimonial house and tried to adjust with every sort of tortures and injuries which were inflicted upon me, but after grasping of so much of pain, trauma, and injury I was of a positive notion that someday "Good Light Will Be Preached upon Them", from which I didn't lodge any complaint against my husband or the Mother and Father In Law. It is also pertinent to mention that I was not only tortured in my matrimonial house but also in my parental house i.e., Shaktigarh, Dist: Jalpaiguri. The situation even worse in the month of July, 2022 when my mother in law instigated me to commit suicide after tremendous physical torture upon me finding no their alternative I fled from the matrimonial house and took shelter nearby club wherein the members of the said club called my father, and thereafter my parents rescued me from that said situation, and bring me back to my parental house, and since then i.e., 24.08.2022 I am living in my parental house and all the basic amenities of survival are now being borne by my poor parents.

In view of above you are requested to take appropriate & proper legal step / steps against the aforesaid persons as per law.
