I, Suman Sengupta, Son Of Ashoke Sengupta, Divisional Engineer & Station Manager, Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India, would like to lodge a complaint regarding damage of electrical equipments, property of WBSIEDCL. At Around 12:30 PM on 14.03.2023 afternoon Power House Customer Care center received information regarding damage of electric equipments and accessories in BSF Road, Salugara, Near Beat Office, PO Salugara, PS Bhaktinagar, Dist Jalpaiguri, Siliguri. On reaching the site, it was found that a Vehicle, had severely broken one 8 meter PCC pole along with other accessories. As reported by the local people that the vehicle was a truck with vehicle no WB41 E 6784 (ph no- +919547243156, 9800409724 Ganesh Kr Chettri) had damaged the infrasuacture. The total damages caused by the vehicle are approximately around Rs 16974/- (Rupees Sixteen Thousand Nine Hundred Seventy Four Only). Thus you are requested to kindly initiate an investigation against the culprit/s under Section 139 of the Indian Electricity act 2003 amended on 2007.
