I, Suman Sengupta, Son Of Ashoke Sengupta, Divisional Engineer & Station Manager, Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India, would like to lodge a complaint regarding damage of electrical equipments, property of WBSIEDCL. At Around 09:30 PM on 15.03.2023 evening Power House Customer Care Center received information regarding damage of electric equipments and accessories in front of hanuman mandir Salugara, PO Salugara, PS Bhaktinagar, Dist Jalpaiguri, Siliguri. On reaching the site, it was found that a Vehicle, had severely broken one 8 meter PCC pole along with other accessories, the property being of WBSIEDCL. It was found that a truck with vehicle no WB78 5577 (ph no- +919832033959) had damaged the infrastructure. The total damages caused by the vehicle are approximately around Rs 16367/- (Rupees Sixteen Thousand Three Hundred Sixty Seven Only).

Thus you are requested to kindly initiate an investigation against the culprit/s under Section 139 of the Indian Electricity act 2003 amended on 2007.
