Sir,

In producing herewith one arrested accused person namely Bijay Lama-32yrs s/o Lt Nima Lama of Salugara Bazar, PO Salugara, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list viz:

- (1) 17 (seventeen) bottles of SHANGRILA whisky each bottle containing 750 ML (Made in Sikkim)
- (2) 09 (Nine) bottles of HIT beer each bottle containing 650 ML (Made in Sikkim)
- (3) 03 (Three) no's of Royal Blue whisky each bottle containing 750 ML (Made in Sikkim) which was kept in two paper cartoon in his shop.

I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 15.03.23 at 16.15 hrs received a source information from Salugara Bazar under Bhaktinagar PS that one person namely Bijay Lama has gathered huge quantity of liquor in his possession at above noted place for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-766 dated 15.03.23. As per your kind instruction myself along with ASI Dipak Karmakar, C/374 Debraj Biswas, CVF/014 Labannomoy Barman, CVF/614 Sumit kumar Roy, C/1431 Dilip Barman proceeded to the PO to work out the information. At 16.35 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession which was kept in his shop style as BIJAY VARIETY STORE at Salugara Bazar. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him u/s 41 Crpc after issuing proper arrest memo (The seizure was made in between 16.50 hrs to 17.30 hrs)

I therefore request you a specific case may kindly be started against the accused person namely Bijay Lama-32yrs s/o Lt Nima Lama of Salugara Bazar, PO Salugara, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
