Sub: Intimation regarding damage of WBSEDCL property due to collision by a truck bearing Registration No.: WB73C3236 on 16.03.2023 at around 05.00 am in the early morning at Santinagar Bou Bazar (near MLA Sikha Chatterjee House), PS – Bhaktinagar under the electrical jurisdiction of Subhaspally CCC.

Dear Sir,

In reference to the subjected matter, this is to inform you that a truck bearing Registration No.: WB73C3236 collided with WBSEDCL's LT network installed at Santinagar Bou Bazar (near MLA Sikha Chatterjee House) on 16.03.2023 at around 05.00 am in the early morning, as gathered, under the jurisdiction of Bhaktinagar PS (Ashighar Out-post) & damaged WBSEDCL's property including one PCC 8M Poles, LT AB Cable, ACSR Conductors along with other fittings & service cables having approximate demurrage value of Rs. 30,000.00. A formal quotation will be raised soon after restoration. Moreover, it resulted to 'No Power' situation at the nearby areas causing inconvenience to the public; however, we have already started necessary restoration work at the spot.

So I request you to take cognizance against the aforesaid matter and consider this correspondence as formal complain u/s 139 & 140 of the Electricity Act, 2003 (read with amendments) & under relevant sections of IPC/CrPC to initiate further necessary action from your end.
