Sir,

In producing herewith two accused persons namely (1) Jagadish Barman (M/31 yrs) S/O- Naren Barman of Gopalpur, PS- Mathabhanga, Dist- Cooch Behar present address Haiderpara, W/NO- 40, PS- Bhaktinagar Dist- Jalpaiguri (2) Amit Sarkar (M/34) S/O- Lt Pulin Sarkar of Jalpaimore, Nichpara, PS-Siliguri, Dist- Darjeeling (not Verified) in custody and the following property under seizure along with seizure list-

- (i) 49(Fortynine) pieces of vials of LUPIGESIC Injection composition with Buprenorphine Hydrochloride IP equivalent to Buprenorphine 0.3 mg each vials containing 02 ML (Total 98 ML) and Marked as exhibit-"A"
- (ii) 49(Fortynine) pieces of vials of PHENERGAN Injection which composition with hydrochloride 1P 25mg each vials containing 02 ML (total 98 ML). and Marked as exhibit-"B"
- (iii) 49(Fortynine) pieces of vials of DIAZEPAM Injection composition with Diazepam 1P 5mg each vials containing 02 ML(total 98ML) and Marked as exhibit-"C"
- (iv) One printed handbag with handle.

I, PSI Koushik Raha s/o Jitendra Raha of Bhaktinagar PS/ SPC do here by lodged this complaint to the effect that on 17.03.2023 at 15.20 hrs received a secret source information that two persons having possession of huge quantity of Narcotics Substances in their possession without valid documents and standing at Haiderpara Market Complex, Ward No-40 PS-Bhaktinagar, Dist- Jalpaiguri to sell the same to his designed customer for his wrong full gain. Accordingly the information was diarized vide BKN PS/SPC GDE No. 1048 Dtd. 17.03.2023 and informed with a written letter to the I/C Bhaktinagar PS/SPC about this information. As per kind order of I/C Bhaktinagar PS/SPC myself along with, SI Ranjit Kr. Paul, ASI Dipak Karmakar C/1431 Dilip Barman, CV/614 Sumit Kr. Roy CV/014 Labanyamay Barman, CV/619 Dharmendra Roy all of Bhaktinagar PS/SPC left by govt. vehicle vide BKN PS/SPC M.C.C No-538/23 Dt. 17.03.2023 to verify the veracity of information corresponding BKN PS/SPC, GDE.NO. 1049 Dated. 17.03.2023. At the time of departure from Bhaktinagar PS I bring digital weighing machine, envelope, white paper, sealing wax, gum, seal etc. At about 16.05 hrs on arrival there I called two disinterested witnesses from the spot who were present & available there at that time namely (i) Manoj Lama-38yrs s/o- Gopi Lama of Gitalpara, W/No-40, P.S- Bhaktinagar, Dist- Jalpaiguri (M- 9832385944) and (ii) Md. Appu 26yrs s/o Lt. Md. Mustakim of Ashrafnagar, W/N-40, PO- Haiderpara, P.S- Bhaktinagar, Dist- Jalpaiguri (M-8101942334) also disclosed the matter regarding our information. I also requested them by issuing a written letter for their Consent to accompany us in the whole process during search and seizure if necessary, and obtain necessary permission of their presence as witnesses in the entire process of Search and Seizure under relevant provision of law as witness. As per identification by source I managed to detain the said persons. After disclosing our identity, we detained two persons with

strong reason to believe that they are illegally carrying Narcotics Substances for supplying/ selling the same in Siliguri area for his wrongful gain. On being asked they disclosed their identity as noted above and admitted that they possessed Narcotics Substances. Then I asked them whether they wanted to be search in presence of an Executive Magistrate or any Gazetted Officer and they agreed to search by any one. I served them a notice in accordance with provisions of law in this regards. I also offered the independent witnesses and apprehended person to search our Police Party as per provision. But they refused to search the police party. Then I informed Shri, Santanu Tarafder ACP (A/P)SPC as he was detailed for Special Executive Magistrate to present at in front of Haiderpara market complex for the search and seizure. I disclosed the identity of Shri, Santanu Tarafder ACP (A/P) SPC to the apprehended person and witnesses as a Special executive magistrate. Thereafter under the supervision Shri, Santanu Tarafder ACP (A/P)SPC and in presence of him and independent witnesses I conducted search of the above apprehended persons keeping strict regard and found the articles as per seizure list which was possessing/carrying by the apprehended persons. On being asked they further confessed in presence of Special executive magistrate and other witnesses that they procured the Narcotics Substances clandestinely for the purpose of selling to his designed Customers in order to earn huge amount of money for their wrongful gain. On interrogation they disclosed that they have been dealing in such illegal drug trafficking business and selling the same to the adjacent area of Siliguri. On examination of the alleged apprehended persons noted above regarding any documents for carrying/possessing of said Narcotics Substances they failed to produce any documents or license in support of possessing of such drugs. Then as per direction of Shri, Santanu Tarafder ACP (A/P)SPC I seized the articles under proper seizure list and Label under the supervision of Shri, Santanu Tarafder ACP (A/P)SPC in presence of witnesses duly signed by them as well as the accused persons and marked the seized exhibits as noted above.

The seizure and label was made between 19.35 hrs to 20.45 hrs. The whole process of search and seizure was video graphed by Photographer Somnath Chatterjee of Arabinda Pally, W/N- 22 PS Siliguri Dist Darjeeling. Then I arrested the above noted accused person u/s- 41 Cr.P.C after observing all formalities of arrest and disclosed him cause of arrest issuing necessary Memo of Arrest. The copy of seizure list and Memo of Arrest was supplied to above noted alleged persons under proper receipt as the alleged accused person violated the terms and condition of N.D.P.S Act possessing Narcotics Substances without any lawful documents.

Under the above circumstances, a specific case have been started against the accused persons namely (1)Jagadish Barman (M/31 yrs) S/O- Naren Barman of Gopalpur, PS- Mathabhanga, Dist- Cooch Behar present address Haiderpara, W/NO-40, PS- Bhaktinagar Dist- Jalpaiguri (2)Amit Sarkar (M/34) S/O- Lt Pulin Sarkar of Jalpaimore, Nichpara, PS-Siliguri, Dist-Darjeeling (not Verified) and arrange for its investigation.
