I, Sangita Tiwary, Wife of Late Rajendra Tiwary, resident of Sainikpuri, Khaprail, P.S.- Matigara, District- Darjeeling, presently residing at Bindapur Extension, Uttam Nagar, West Delhi, Delhi, would like to inform you I was married to Late Rajendra Tiwary in the year 1990 and out of the said wedlock I have a son namely, Rahul Tiwary, who is presently residing at Delhi. That my husband expired in the year 2009 on account of cancer and after his death my brother-in-law namely, Kamalesh Tiwary, his wife namely, Munni Pandey @ Tiwary and their daughter namely Muskaan Tiwary inflicted enormous tortures upon me and my son Rahul Tiwari because of their greed for property which was purchased by my husband in the name of my mother-in-law. As a result of such tortures, I was compelled to leave our matrimonial house along with my

That my brother-in-law namely, Kamalesh Tiwary and his wife namely, Munni Pandey @ Tiwary and their daughter namely, Muskaan Tiwary had also been torturing my mother-in-law namely Ram Keshi Tiwari and my father-in-law namely, Jatashankar Tiwary for property and because of such inhuman tortures, my parents-in-laws were compelled to file a case under Senior Citizens Act vide Misc Case No. 39 of 2022. That after this case, they have been continuously pressurizing my parents-in-laws to withdraw the case otherwise they will make their life hell. That Munni Pandey has also lodged false F.I.R. against my father-in-law and my son. That due to the continuous tortures and threats, my father-in-law fell unconscious and he was admitted in Maharaja Nursing Home, Siliguri on 24.2.2023 and he was discharged on 28.2.2023. That to look after my parents-in-laws, I came to my matrimonial house from Delhi on 10.3.2023 and seeing me my brother-in-law, Kamalesh Tiwary started to pass vulgar and abusive remarks calling me randi and threatened to rape me if I do no leave my matrimonial house. That Munni Pandey @ Tiwary and Muskaan Tiwary also

joined him stating that they will file a false case against me as they did against my son Rahul Tiwary. That inspite of listening to such threats when I did not vacate my matrimonial house thinking about the welfare of my parents-in-laws, today on 14.3.2023at about 8 a.m., Kamalesh Tiwary, Munni Pandey @ Tiwary, Muskaan Tiwary and her husband namely, Pankaj Choudhary, (who is residing in my matrimonial house since last one month), came to the room of my parents-in-law and started to shout at them on the top of their voice being fully aware that my father-in-law is not well and asked to withdraw the case filed under Senior Citizen Act else we will be on street and they will force my parents-in-laws to begging. They will not give inch of the property to my parents-in-law and will go to the extent of killing them. That Pankanj Choudhary said that he is an influential man and if required he will kill my son Rahul Tiwary who stays at Delhi. That when I opposed to all this, Munni Pandey caught hold of my hair and when my mother-in-law came to save me, Pankaj Choudhary pushed my mother-in-law as a result she fell down. That my brother-in-law Kamalesh Tiwary pulled my saree and grabbed me and touched my private parts and his wife commented that she will make her husband sleep with me. That Muskaan Tiwari Pankaj Choudhary started laughing and I felt immensely humiliated. That my father-in-law seeing such activities, shouted for help and tried to save me from the clutches of my brother-in-law and thereafter he dialled the police from his mobile. Seeing this, Kamalesh Tiwary told the police is in his pocket and left from my parents-in-laws room threatening that they will evict us at any cost. That if anything happens to me, my parents-inlaws or my son Rahul Tiwary, then Kamalesh Tiwary, Munni Pandey @ Tiwary, Muskaan Tiwary Pankaj Choudhary will be liable for the same.

I therefore request you to inquire into the matter and take necessary action against Kamalesh Tiwary, Munni Pandey @ Tiwary, Muskaan Tiwary Pankaj Choudhary.
