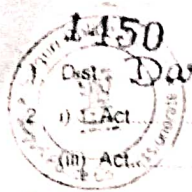

Respected Sir,

I the undersigned would like to inform you the following incident:-

That at 10:00 PM on 18:03:2023 at around Thanamore near Hanuman mandir, Lahu Prasad slo Kate Ram Prasad came from the back side and pushed me towards floor and started thrashing me with blows and legs and after that he kicked me over chest and was about to punch me with a stone lying near there.

That sir, somehow one person known as Prem (9002679491); came in the middle and helped me and rescued me from him.

That Lahu Prasad have had also pushed me from the backside around 10-15 days ago and was asking RS:500 (five hundred) from me and when I denied to give him RS500/- Lahu Prasad said that he would try to assault me again near Thanamore.

That sir, I am a kidney transplant patient and after the above incident I am in fear that he may hurt me with dire consequences and moreover I have seen Lahu Prasad most of the time at Thanamore, he had also threatened my son Pranav Prasad too.

That sir, This is my humble request to you that I am a 52 years old and also a patient please take proper action so that he may not try to harm me again in future.


