I, Smt. Kamala Sarkar @ Kamala Banerjee, wife of Sri Gaurav Sarkar, Daughter of Late Gautam Banerjee, resident of Kishanganj, Dey Market, Line para, Near Pratab Medical School, presently residing at Adarsha Nagar, Near Govt Sew Mill, Ward No. 4 of Siliguri Municipal Corporation, Siliguri, Post Office- Siliguri Bazaar, Police Station- Siliguri would like to draw your kind attention to the fact that myself and Sri Gaurav Sarkar was in love and we were later married on 16.06.2023 at Panjpara Kali Mandir in presence of my brother, my mother-in-law, Father-in-law, Sister-in-law, brother-in-law and other relatives presence and later was taken to my Sister-in-law house at Kishanganj.

On 18.8.2023, as per instruction of my father-in-law and mother-in-law, my husband dropped me to my parental home stating that after my sister-in-law returned from Goa they will arrange for reception and then take me to my in-law home.

On 12.10.2022 on being forced by my husband, Father-in-law and mother-in-law, my mother arranged for a reception party on behalf of my in-laws at Adarsh Nagar, Community hall, my mother-in-law and sister-in-law took all the gifts by my family friend, relatives, etc and later on the even day they took me to my sister-in-law house situated at Pradhan Nagar, Siliguri and on the next day i.e 13.10.2022 they took me to my in-laws house at Kishanganj.

Just within few days my mother-in-law and my father-in-law started torchering me physical and mentally by pulling my hairs, slapping on my face and stating that my son would have got at least 20 lakhs of rupees plus gold and vehicle, if they have arranged his marriage and a beggar would give his daughter more gold and cash than you have bought and took all my jewelry from me I always complaint about this to my husband to which he replied that within few days everything would be fine. But to the surprise later my husband also joined my mother-in-law and my father-in-law and their inhumane torcher increased day by day. One day my husband and father-in-law caught me in kitchen and my mother-in-law put a hot chimli in my hand burning my hand causing permanent burn mark in my right hand. But as my mother is aged and suffering from various age related problem and my father died so I kept bearing their inhumane torcher so that my I my mother condition did not deteriorate thinking of my problem. But I was not able to hide this from my mother and informed her about my problem to which she replied that after having baby every thing will be fine, give some time and don't worry as it takes time to adjust in new family.

I was forced to change my ph. No, my facebook account and not permitted to talk with neighbors and relatives.

In the month of January, 2023 I came to know that I am pregnant and I was happy as my stated that everything will be fine after having a baby and I informed my husband about my pregnancy. But I was surprised to hear that whose baby is this, who will bear the expenses, abort this child or else I will kick kill this child.

After that I stated all the incident to my mother to which she stated that I will bear all expenses for this child and every time whenever there is issue my husband brought me to my mother house, took money and then get me treated/visited the Doctor.

In the mean time my mother-in-law and my father-in-law removed dish washer from the fast food hotel/counter they were running and I was forced to wash the utensil in the shop as a servant.

My in-laws and my husband always used to ask me to bring cash, gold and furniture inspite of knowing the fact that I have no father and my old mother is not in a position to fulfil any of their demands and whenever I stated this fact that my husband an in-laws, they physically abused me hitting me in my face creating permanent spot in my face.

Recently on 03.03.2023, when I was seriously ill my husband, my mother-in-law and my father-in-law slapped me in my stomach and told to abort the child or else they will kill me and my child together and later my husband brought me to Siliguri for treatment and as the Dr. Mallika Mukherjee was not available, my husband dropped me to my paternal house and left for market where my mother called my in-laws and asked their permission to keep me at home for few days to which they responded badly using slang language and stated to keep me permanently.

Later at around 5.00 P.M. on 03.03.2023 my husband came to my paternal home told me that we are leaving for Kishanganj without getting me examined by the Doctor and took me. On just waking few minutes my husband started to hitting me in my face and stomach stating that yesterday hitting by me and my parents have not yet killed the child and forcible took me to junction and took a bus to Kishanganj. On reaching Bagdogra I became seriously ill and unconscious after vomiting and when I woke up it was around 11.30 P.M and I was admitted to Bagdogra Hospital. Next day i.e 04.03.2023 my husband forcible discharged me and took me to Kishanganj. On reaching Kishanganj my in-laws again started hitting me and someone of our neighbor informed my family at Siliguri so my mother, sister along with my neighbor reached Kishanganj on 05.03.2023 where my in-laws and my husband quarreled and my mother bought me to Siliguri.

After reaching I was seriously ill and took rest at home and consulted doctor. On 10.03.2023 I consulted a gynaecologist, on 14.03.2023 at around 1.00 A.M. suddenly bleeding occurred and my sister and mother took me to maya sanyal nursing home where they admitted me where Dr. stated to conduct Ultrasonography where the report stated that the baby is down and have to be aborted and stated that they will not conduct abortion without husband permission and when I informed my husband about this incident he did not respond and stated I cannot come now and later my mother and sister were forced to take me to Pragati Nursing home and abort the child.

Sir, in this condition I request you to kindly take necessary action against my mother-in-law namely Smt. Gulabi Sarkar, my father-in-law namely Sri Gopal Sarkar and my husband Sri Gaurav Sarkar for trying to kill me and killing my child.
