Sub: - FIR for damage to WBSEDCL's LT Network at Papia Para (near Gas Godown) on 19.03.2023

Dear Sir,

This is to bring to your kind attention that a truck bearing **Registration Number: HR47E5802** collided with **WBSEDCL's LT Network at Papia Para (near Gas godown/warehouse)** & damaged a considerable portion of it causing financial loss to WBSEDCL as well as inconvenience to the people to the surrounding area due to 'No Power' condition. *As reported, the incident took place on 19.03.2023 at around 02:30 am in the night;* our LT Mobile Van, immediately after receiving the information, rushed to the spot & isolated the faulty part to avoid any undesirable incident & restored power up to the extent possible. The alleged truck Driver's name is Suraj Ram (Mobile No.: 9060848476), as gathered.

One PCC 8Mtr pole along with a few quantities of ACSR Conductors & LT AB Cable, Iron Bracket & other associated fittings/accessories & few service cables are primarily assessed to be damaged as a result of the collision which is primarily assessed to the tune of **Rs.25,000.00**. However, WBSEDCL has already started the restoration work at the location & a formal quotation containing demurrage cost will be issued to the truck-owner soon after assessing the actual extent of damage.

Hence, your good office is requested to take cognizance of the matter & consider this as formal intimation to take necessary action u/s 139 of the Electricity Act, 2003 (read with amendments) & other relevant laws of the land.
