Sir,

In producing herewith two (02) arrested accused persons namely Samiul Sheikh (21) s/o Kismat Sheikh of Kaliachowk, PS Kaliachowk, Dist. Malda and (ii) Md. Samirul Islam (19) s/o Samsul Seikh of Kaliachowk, PS Kaliachowk, Dist. Malda along with the following articles under seizure as per seizure list;

1. One Auto Pistol inscribed as 'Auto pistol Made USA' having its trigger, hammer and firing pin measuring approx. 8.3 inch (approx.) including its butt, body. [The articles have been found kept concealed on the right side of waist of accused Samiul Sheikh marked as "Exhibit-A"]

2. Two live ammunitions inscribed as "KF" and "7.65" on its percussion cap found inside the left side pocket of blue color jeans pant of accused Md. Samirul Islam & marked as "Exhibit-B"]

I, SI Abhishek Theengh, S/O- Sri Suchandra Kumar Theengh of Pradhan Nagar Police Station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted two (02) arrested accused person namely Samiul Sheikh (21) s/o Kismat Sheikh of Kaliachowk, PS Kaliachowk, Dist. Malda and (ii) Md. Samirul Islam (19) s/o Samsul Seikh of Kaliachowk, PS Kaliachowk, Dist. Malda (not verified) to the effect that today on 20.03.2022 at about 16.05 hrs I received a specific source input that two person were standing near Siliguri junction under Pradhan Nagar PS, for committing heinous crime. They had carried and possesses small arms & ammunition with them. The matter was diarized vide Pradhan Nagar PS GDE No.1160 Dt. 20.03.2023. Accordingly, I informed the matter to your kind notice, and subsequently, as per your kind direction myself along with ASI Ashit Singh, Const- 762 Mojhibur Rahaman, CV/128 Ajay Sahani, CV/223 Swapan Chettri and CV/645 Pankaj Das all of Pradhan Nagar PS and along with investigation kit left for Siliguri Junction by govt. vehicle to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No.1160 Dt. 20.03.2023.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter I along with force reached at Siliguri junction at 16.45 hrs and being pointed by my source apprehended the above noted accused person named Samiul Sheikh and Md. Samirul Islam searched them immediately and found the above noted articles from their conscious and exclusive possession. On demand they failed to produce any documents in support of their possessing and carrying of such type of fire arms and ammunitions. Hence, it is evident that the accused persons namely Samiul Sheikh and Md. Samirul Islam exclusively & consciously possessed this improvised fire arms loaded with live ammunition illegally with some ill motives.

Thus, their involvement in carrying and possessing illegal fire arms and ammunition is established, I seized and labeled the above noted articles at the spot under proper seizure list duly signed by them and in presence of independent witnesses and also put my signature on the seizure list and label. The seizure time was made between 17.05 to 18.10 hrs. Subsequently, I also arrested them preparing memo of arrest informing them the ground of their arrest.

From the above noted facts and seizure of incriminating articles there is a strong reason to believe that the accused persons namely Samiul Sheikh and Md. Samirul Islam had carried the said fire arms and ammunitions with an objective to commit heinous crime in the locality and on being interrogated regarding the illegal arms and ammunition recovered from their exclusive and conscious possession, they revealed that they have procured the arms and ammunition from somewhere in Malda area.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely Samiul Sheikh (21) s/o Kismat Sheikh of Kaliachowk, PS Kaliachowk, Dist. Malda and (ii) Md. Samirul Islam (19) s/o Samsul Seikh of Kaliachowk, PS Kaliachowk, Dist. Malda and arrange for its investigation.
