I, Dr Anshel Bagchi, was travelling with my wife & drove in my own vehicle, bearing no. DL9CAT 1647 from Dargaching More to Sarak more via Hill Cor Road, when in front of Heritage Hotel, two persons, both drunk ~~with~~ were driving a vehicle, bearing no. WB74AQ6385, abused me, my driver, Suresh Sarkar, and my wife, Nibedita Bhattacharya Bagchi. They physically assaulted us and also hit our vehicle. The local Traffic Police guard was present and he saw the whole episode. I hereby



want to inform you about the murder and
