I SI, Prakash Saha of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 20.03.2023 around 06:40 AM while on duty at Hill Cart Road found one (1)TOTO without any registration number stationed near Airview More in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they failed to produce the same.

Therefore I would request you to kindly start a specific case in terms of Section of 188/283 IPC and other sections of law deemed fit against the said person with necessary action as applicable.
