In producing herewith One (01) arrested accused person namely Bibek Shaw (34 yrs) S/O Raj Kr. Shaw of Bhangapul, Baniakhari PS- Matigara, Dist- Darjeeling along with the following seized articles viz:

i] 39 (thirty nine) pieces of vials of LUPIGESIC Injection composition with Buprenorphine Hydrochloride 1P equivalent to Buprenorphine 0.3 mg each vials containing 02 ML (Total 78MI) and Marked as exhibit-"A"

ii] 39 (thirty nine) pieces of vials of PHENERGAN Injection composition with Promethazine IP 25 mg, Hydrochloride IP 25mg each vials containing 02 ML (total 78MI) and Marked as exhibit-"B"

iii] 39 (thirty nine ) pieces of vials of DIAZEPAM Injection composition with Diazepam 1P 5mg each vials containing 02 ML(total 78Ml) and Marked as exhibit-"C"

iv] One white color carry bag which contain Exhibit A, B, & C and Marked as exhibit-"D".

I, SI Sailesh Subba of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused person to the effect that today on 19.03.2023 at 21:25 hours, a source information was received that one person is transporting contraband "Narcotic Substance" illegally for selling the same to his designated customers for his wrongful gain at Mirik Khaprail Road in front of Dhriti Automobile (Toto Repairing garage).

The matter was diarized vide Matigara PS GDE No. 1043 dated 19.03.2023. Accordingly, I informed the matter to Officer-in-charge of Matigara PS/SPC in writing and as per his kind instruction, myself along with SI Sajal Roy, SI Agen Lepcha, ASI Tapan Das, C/219 Sanatan Chitrakar, C/974 Mintu Sen and CV/ 643 Animesh Roy all of Matigara PS, Siliguri Police Commissionerate, left for Mirik Khaprail Road in front of Dhriti and MCC No 205 dated 19.03.2023 to verify the veracity of the information.

At the time of departure from office I took envelope, white paper, sealing wax, gum, seal, digital weighing machine (Certified by the weight and Metallurgy department) and other investigation kits as it would be needed if

At around 21:45 hours, we reached Mirik Khaprail Road and called two independent witnesses namely (1) Dipak Sarkar (27) S/O Mohan Sarkar and (2) Gopal Sarkar (26) S/O Chandu Sarkar both of Rananagar, PO+ remain present as witnesses during the process of search and seizure. I, also requested them to accompany us and Somnath Chatterjee s/o Sushil Chatterjee of Aurobindo Nagar, Ward No 22, PS Siliguri, over his mobile phone (9800325284) to come with his video camera and requested him to record the entire process of search and seizure.

Thereafter we parked our vehicle at a considerable distance at Mirik Khoprail road from Dhriti tomobile (Toto Repairing Garage) P.S Matigara, Dist. Darjeeling as indicated by our source.

Then being shown and identified by my source we procedeed towards in front of Dhriti Automobile oto Repairing Garage). We saw a person standing in front of Dhriti Automobile (Toto Repairing Garage) with the white color carry bag on his right hand suspected to be containing contraband articles. On seeing the police m, he became nervous and tried to run away from the spot. I approached the said person and disclosed my ntity as Police Officer of Matigara Police Station and disclosed the identities of the police team accompanying

On being asked, he disclosed his identity as Bibek Shaw (34 yrs) S/O Raj Kr. Shaw of Bhangapul, niakhari PS- Matgara, Dist- Darjeeling. We informed him that we had specific information that he had in his seession a huge quantity of "narcotic substance" on your belongings and that we intended to search him and the rry bag that he was carrying. Initially he denied having any "Narcotic substance" with him and that the bag ntained other articles. But I told him that we would search his person and the bags he was carrying. Eventually admitted that the bags contained "Narcotic Substance" and he was waiting for a customer to deliver the same, stated that he did not have any license to sell "Narcotic Substance" and that he procures the same from one rson from elsewhere and then sells the same to his customers illegally, for his wrongful gain. It was clear that has illegally procuring and transporting the "Narcotic Substance".

Thereafter I served him a Notice giving him the option of "whether he wanted to be searched in presence Executive Magistrate or by any Gazette Officer". To this, he agreed to be searched by any one of them. I also fered the independent witnesses accompanying us, and the accused person to search our Police Party as per ovision, but they refused to search the police party.

I then sent ASI Tapan Das with a requisition to Special Executive Magistrate, Shri Pasang T. Butia ACP raffic East) SPC, requesting him to come to the spot for supervising the process of search and seizure.

At around 22:25 hours, ASI Tapan Das returned at the spot along with Special Executive Magistrate, Shri assang T. Bhutia ACP (Traffic East) SPC and he disclosed his identity as Special Executive Magistrate, to the tained person as well as the independent witnesses told them that he would be supervising the process of search id seizure.

As instructed by Ld. Special Executive Magistrate and under his supervision in presence of two dependent public witnesses, search was conducted of the detained person Bibek Shaw, observing all formalities, ut nothing could be recovered from his person except wearing apparels. Then the carry bag was searched and en found above noted seized contraband articles inside the bag.

On being asked about the valid documents the apprehended person was unable to produce any ocument/license in support of that "Narcotic Substance" that was in his possession, by Shri Pasang T. Butia ACP Traffic East) SPC, Special Executive Magistrate. He confessed that he was carrying this business illegally. He sed to procure it from elsewhere and used to sell it to his customers for his wrongful gain and that he was raiting for his designated customer when the police team reached at the spot.

As instructed by Shri Pasang T. Butia ACP (Traffic East) SPC, I seized all above noted articles under roper seizure list in presence of the above noted independent witnesses and took the signatures of the witnesses

81 Saileth Subber Dete - 20/03/2023 d the accused person on the seizure list. I also then labeled and sealed the "Exhibit-A", Exhibit-B" and xhibit-C" in presence of the Special Executive Magistrate, independent witnesses and the accused. The seizure d label was made in between 22:35 hr to 23:50 hrs. The whole process of search and seizure was videographed the videographer.

The apprehended accused person namely Bibek Shaw confessed before the Special Executive Magistrate d other witnesses that he used to procure "Narcotic Substance" clandestinely from elsewhere for the purpose of ling the same to his designed customers for his wrongful gain by illegal means and that he was doing this for a g time.

I then arrested the apprehended accused person namely Bibek Shaw (34 yrs) S/O Raj Kumar Shaw of angapul, Baniakhari PS- Matigara, Dist- Darjeeling under proper Memo of Arrest for violating the terms and addition of the NDPS Act, after observing all guidelines of Apex Court. His ground of arrest was duly amunicated to him.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly started against the accused person named Bibek Shaw (34 yrs) S/O Raj Kr. Shaw of Bhangapul, Baniakhari - Matigara, Dist- Darjeeling and arrange for its investigation.
