shouting filthy languages along with dire threatnings,
I myself, my brother namely Subhadeep Sarker and
my brother who was sleeping, ~~was~~ woke up due to the
chase and I and my brother requested those
miscreants to disperse from there, they attacked me
with a "Dau" (Sharp Knife) ^{suddenly without any provocation} with an intention
and another attacked my brother with a iron rod with
an intention to kill him. The person who attacked
me caused a dau inflicted injury in my head
several times with ~~which~~ ^{with} the intention to
kill me and I sustained grievous injuries in my
head and ~~was~~ now undergoing stitches in my head.
The person who attacked my brother inflicted several
blows with iron rod in his head with an intention to
kill him which resulted in ^{several} grievous injuries in his head.
At such time we fell down in the ground crying for
help and those miscreants snatched my mobile phone
bearing no. (7908151572). Hearing our ~~hail~~ ^{cry} the
local people gathered there and apprehended three
of them while rest of them fled away. Then the local
people handed over them to the police namely ① Dhaneshwar
② Papu Roy, ③ Hari. Singh.
