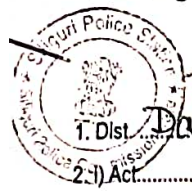

Sir,

In producing herewith two (02) arrested accused persons namely 1) Nahir Ali 46yrs s/o Lt, Abbas Ali of Demdema PO; Salugara near Zama Maszid PS, Bhaktinagar Dist, Jalpaiguri 2) Golam Mostafa 33yrs s/o Late Kamiruddin Ahamed of Vill: Kalikapur PO; Kaliachok near Kaliachok High School PS, Kaliachok Dist, Malda along with following seized articles viz,

- i. One plastic zipper packet in contents 289.70 grams seems to be "Brown Sugar "Marked as Exhibit - "A". out of 10 grams seems to be Brown Sugar taken as sample from mother packet Exhibit- "A" and Styled as Exhibit - "A-1" recovered from the possession of Nahir Ali
- ii. One Mobile Handset Styled as VIVO with one SIM having connection no 9635066115 user of Nahir Ali.
- iii. One plastic zipper packet in contents 294.18 grams seems to be "Brown Sugar "Marked as Exhibit - "B". out of 10 grams seems to be Brown Sugar taken as sample from mother packet Exhibit- "B" and Styled as Exhibit - "B-1" recovered from the possession of Golam Mostafa
- iv. One Mobile Phone Styled as VIVO with two SIM having connection no 7001673366 and 9647532300 user of Golam Mostafa.

I, SI Uday Sankar Mandal of Panitanki TOP-I, Ps, Siliguri under Siliguri Police Commissionerate do here by lodged this complaint against the above mentioned two arrested persons to the effect that on 22.03.2023 at 15.15 hrs received a secret source information that two persons having possessing of huge quantity of seems to be brown sugar and both are standing at Mahakal Pally Main road under the Mahananda Bridge area Ward No- 10 PS, Siliguri for clandestinely disposal of the same illegally. The matter was diarized vide Panitanki TOP GDE No 477 dt- 22.03.2023. Accordingly, I informed the matter to O.C, Panitanki TOP-I as well as IC Siliguri PS, and as per their kind instruction myself along with ASI Mantu Dey, ASI Biswajit Saha, C/702 Latifur Rahaman C/984 Subasish Das and CV/1007 Jiten Roy all of Panitanki TOP, left for Mahakal Pally Main road under the Mahananda Bridge area Ward No- 10 at 15.35 hrs to verify the veracity of the information vide corresponding Panitanki TOP-I G.D.E. No. 478 dtd 22.03.23 and Panitanki TOP-I, M.C.C No 310/2023 Dt, 22.03.2023.

At the time of departure from Panitanki Out Post, I bring spring weighing clock, small balance with stone, envelope, paper, sealing wax, gum, seal etc for seizure labeled on the spot. On way to spot meanwhile I called two independent witnesses nearby the PO, namely i) Sri Sachin Thapa M-42yrs s/o Late Kumar Thapa of Samsing Tea Garden PO+PS, Metli Dist, Jalpaiguri ii) Sri Sibu Khati M- 56yrs s/o Lt, Prem Khati of Durganagar Kumartoli Ward No -04 PS, Siliguri Dist, Darjeeling those were standing near by the PO, and informed them about the information in hand and requested them to accompany us to be remain present as disinterested witness during the search and seizure if necessary. At about 15.50 hrs on arrival there by govt, vehicle (hired) parked the vehicle in a considerable distance as identified by the source we surrounded the place and found two persons are standing at Mahakal Pally Main road under the Mahananda Bridge area Ward No- 10, on seeing the police party they try to flee away from there on hot a chase, we apprehended two persons. On being asked they disclosed their identity as noted above. After disclosing our identity I asked them whether they wanted to be searched in presence of Executive Magistrate or any Gazetted Officer and they agreed to search in presence by any of one. I served them option notice u/s 50 of NDPS Act accordance with provisions of law in this regard in writing and they also gave their approval of being searched by any of one in writing on the said option notice. Accordingly, I informed the matter to O.C. Panitanki TOP-I, regarding interception of two persons with contraband articles said to be Brown Sugar and he informed me over mobile phone to send requisition to Sri Pasang Topgay Bhutia ACP, (Traffic) East, SPC, special Executive Magistrate on the day. Accordingly, I send written intimation to Sri Pasang Topgay Bhutia ACP, (Traffic) East, SPC, Special Executive Magistrate and request him to come down on the spot as early. At about 18.05 hrs Sri Pasang Topgay Bhutia ACP, (Traffic) East, SPC, special Executive Magistrate arrived at the spot. I disclosed the identity of Sri Pasang Topgay Bhutia ACP, (Traffic) East, SPC, as special Executive Magistrate on the day to the accused persons and witnesses. I offered the independent witnesses and the accused persons to search our Police Party as per provision of law but they refused to search the police party. Under the supervision of Sri Pasang Topgay Bhutia ACP, (Traffic) East, SPC, Special Executive Magistrate and in presence of independent witnesses,

I conducted search and recovered one zipper transparent thin plastic packet in contents said to be brown sugar which kept concealed on the pant pocket of Nahir Ali. On interrogation Nahir Ali confessed that the Brown Sugar he procured from Kaliachak Dist, Malda for clandestinely sale the same to his designated customers Bishal Mukhiya s/o Lal Bahadur Mukhiya of Demdema Salugara in a high rate in youth generation. On further search one zipper transparent thin plastic packet in contents said to be brown sugar which kept concealed on the pant pocket of accused Golam Mostafa. On interrogation Golam Mostafa confessed that the Brown Sugar he procured from Kaliachak Dist, Malda from one Md Samim Akhtar s/o Md Dukhu Momin Vill+PO, Jadupur PS, Kaliachok Dist, Malda for clandestinely sale the same to his designated customers at Siliguri area. On demand they both failed to produce any valid documents or license to possessing the huge quantity of Brown Sugar from their possession.

Accordingly, I weight the recovered of zipper transparent thin plastic packet contents said to be brown sugar by the weighing instrument and found total 289.70 grams seems to be "Brown Sugar" Marked as Exhibit - "A" recovered from the pant pocket of Nahir Ali and out of 10 Grams said to be brown sugar taken as sample from the mother Exhibit - "A" in one separate thin plastic zipper packet and marked as "A-1" and one Mobile Handset Styled as VIVO with one SIM having connection no 9635066115 user of Nahir Ali. And another zipper transparent thin plastic packet contents said to be brown sugar by the weighing instrument and found total 294.18 grams seems to be "Brown Sugar" Marked as Exhibit - "B". out of 10 grams seems to be Brown Sugar taken as sample from mother packet Exhibit- "B" and Styled as Exhibit - "B-1" and one Mobile Phone Styled as VIVO with two SIM having connection no 7001673366 and 9647532300 user of Golam Mostafa recovered from the possession of Golam Mostafa.

Accordingly I seized the same and labeled with sealed in presence of Sri Pasang Topgay Bhutia ACP, (Traffic) East, SPC, special Executive Magistrate on the day and independent witnesses and accused persons. Then I seized the above noted articles under proper seizure list and labeled duly signed by the above noted witnesses and the Sri Pasang Topgay Bhutia ACP, (Traffic) East, SPC, special Executive Magistrate on the day and acknowledged by the accused persons. The seizure was made between -18.15 hrs to 19.50 hrs. On further interrogation the apprehended persons Nahir Ali confessed in presence of special Executive Magistrate on the day and other witnesses that the Brown Sugar he procured from Kaliachak Dist, Malda for clandestinely for sale the same to his designated customers one Bishal Mukhiya s/o Lal Bahadur Mukhiya of Demdema Salugara under PS, Bhaktinagar for sale in a high rate in youth generation. On interrogation Golam Mostafa confessed that the Brown Sugar he procured from Kaliachak Dist, Malda from one Md Samim Akhtar s/o Md Dukhu Momin Vill+PO, Jadupur PS, Kaliachok Dist, Malda for clandestinely sale the same to his designated customers at Siliguri area. On demand they both failed to produce any valid documents or license to possessing the huge quantity of Brown Sugar from their possession. Then I arrested the above noted two accused person's u/s- 41 Cr.P.C after observing all formalities of arrest as well as informed them regarding their cause of arrest and issued Memo of Arrest. The copy of seizure list and Memo of Arrest has been supplied to the above noted two accused persons under proper receipt as the accused persons violated the terms and condition of NDPS Act.

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the accused persons namely 1) Nahir Ali 46yrs s/o Lt, Abbas Ali of Demdema PO; Salugara near Zama Maszid PS, Bhaktinagar Dist, Jalpaiguri 2) Golam Mostafa 33yrs s/o Late Kamiruddin Ahamed of Vill: Kalikapur PO; Kaliachok near Kaliachok High School PS, Kaliachok Dist, Malda 3) Md Samim Akhtar s/o Md Dukhu Momin Vill+PO, Jadupur PS, Kaliachok Dist, Malda and 4) Bishal Mukhiya s/o Lal Bahadur Mukhiya of Demdema Salugara PS, Bhaktinagar Dist, Jalpaiguri and arrange for its investigation.
