Sir,

In producing herewith two accused persons named Sudarshan Kumar (24) s/o Sri Ram Kalayan Roy of Basudebpur, PS Mofassil, Dist. Bengusarai, Bihar and Prakash Agarwal (32), S/O- Lt. Sajjad Agarwal of Patelchowk, Bengusarai, Ward No. 23, PS Nagar, Dist. Bengusarai, Bihar (not verified) under arrest along with following articles under proper seizure.

1. Seventeen (17) bottles of Royal Castle Blue Premium Whisky, Mfg. Date 16.01.2023, each bottle containing 375 ML, MRP Rs. 128.00 per bottle seized from the possession of Sudarshan Kumar and marked as Exhibit - A.

2. Sixteen (16) bottles of Mc. Dowell's Celebration Rum, Mfg. Date 25.11.2022, each bottle containing 750 ML MRP. Rs. 570.00 per bottle seized from the possession of Prakash Agarwal and marked as Exhibit - B.

3. Two Pittu Bags in which Exhibit A and Exhibit B was recovered and seized.

I, SI Abhishek Theengh of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused persons namely Sudarshan Kumar (24) s/o Sri Ram Kalayan Roy of Basudebpur, PS Mofassil, Dist. Bengusarai, Bihar and Prakash Agarwal (32), S/O- Lt. Sajjad Agarwal of Patelchowk, Bengusarai, Ward No. 23, PS Nagar, Dist. Bengusarai, Bihar (not verified) to the effect that today on 22.03.2023 at 17.55 hrs received a source information that two person was standing at Siliguri Junction under Pradhan Nagar Police Station with huge quantity of illicit liquor without any valid license.

Accordingly, I informed the matter to your good notice and as per your kind direction I along with ASI Ashit Singh, CV/128 Ajay Sahani and CV/645 Pankaj Gupta had been to Siliguri Junction under Pradhan Nagar Police Station to verify the veracity of source information. On reaching there and as identified by the source found that two person was standing with two pittu bags with illicit liquor at their possession. Subsequently, I along with my force cordoned the spot and was able to detain the above noted persons. Subsequently on being asked the apprehended persons disclosed their name and identity as noted above and stated that they had come to Siliguri to sell the said mentioned articles.

Further being searched the above noted seized articles were found in the two bags from their possession. On demand they failed to produce any valid license/papers for the articles which was recovered from their possession. On further interrogation they stated that they are involved in selling and possessing of liquor without any valid license for last 06 (six) months for their illegal gain. Then I seized and labeled the above mentioned illegal illicit liquors under proper seizure list in presence of witness and arrested the above-mentioned person named Sudarshan Kumar (24) s/o Sri Ram Kalayan Roy of Basudebpur, PS Mofassil, Dist. Bengusarai, Bihar and Prakash Agarwal (32), S/O- Lt. Sajjad Agarwal of Patelchowk, Bengusarai, Ward No. 23, PS Nagar, Dist. Bengusarai, Bihar (not verified) after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 18.25 hrs to 19.30 hrs at the spot and arrested them after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Sudarshan Kumar (24) s/o Sri Ram Kalayan Roy of Basudebpur, PS Mofassil, Dist. Bengusarai, Bihar and Prakash Agarwal (32), S/O- Lt. Sajjad Agarwal of Patelchowk, Bengusarai, Ward No. 23, PS Nagar, Dist. Bengusarai, Bihar (not verified) under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
