I, Sri Amulya Mandal, Son of Late Rebati Mandal, Resident of Noukaghat Main Road, P.O. Siliguri Bazar, P.S. New Jalpaiguri, Dist. Jalpaiguri do hereby lodge this written complaint against 1. Kali Mohan Roy, Son of Late Ramesh Chandra Roy, resident of Gatmabari, P.O. Mahananda Project, District - Jalpaiguri, 2. Bashu Roy, Son of Nitai Roy, resident of Chayavitta, P.O. Fulbari, District - Jalpaiguri, and 3. Paisanju Roy, Son of Banga Singh Roy, resident of Changrabandha, P.O. Fulbari Hat, District - Jalpaiguri as follows:

- Received on 18.03.23 vide GDE No-843 dt. 18/03/23 and started by P.S. case no. 248/23 dt. 18/03/23 U/S 447/465/467/468/471/387/506/1205 IPC and endorsed to SI Kamalash for its investigation.*
1. That one Tarbaneshawari Roy was the recorded owner of 4.53 acres of land in various plots being R.S. Plot Nos. 348, 348/948, 349, 393/959, 347 and 392/958 recorded in R.S. Khatian No. 318/5 within Mouza - Binnaguri, Pargana - Baikunthapur, J.L. No. 03, Sheet No. 17 under New Jalpaiguri Police Station, District - Jalpaiguri.
 2. That the said Tarbaneshawari Roy during her lifetime in the year 1960 sold 3.33 acres of land out of 4.53 acres in favour of one Radha Mohan Ghosh and thereafter by successive registered Deeds of Sale the said land measuring 3.33 acres was purchased by my father Rebati Mandal (since deceased) vide a registered Deed of Sale being no. 5523 in the year 1992 and during his lifetime my father sold some amount of his purchased land.
 3. That my father died on 18.04.2012 and presently L.R. Plot No. 1057 corresponding to R.S. Plot No. 393/959 consisting of an area of 40 decimals is recorded in L.R. Khatian No. 1057 in the name of my deceased father. The said land is in the ownership and possession of me and my other brothers who are the legal heirs of our late father.
