Sir,

I SI, Alip Kr Paul of Fulbari Highway Traffic Out Post, SPC beg to lodge a written complaint that on 20.03.2023 around 19:10 hrs, while on duty at Uttarkannya More AH2 road found one (1) TOTO without any registration number stationed near Uttarkannya More in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained the said TOTO and on being asked the driver disclosed his identity as Md Amir C/O Md Rukimuddin, Vill: Fulbari Pradhan Para, PO: Fulbari Hat, PS: NJP, Dist: Jalpaiguri, Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they failed to produce the same.

Therefore I would request you to kindly start a specific case in terms of Section of 188/283 IPC and other sections of law deemed fit against the said person with necessary action as applicable.
