Respected Sir,

I, ASI Basudeb Ch Banerjee, of Bagdogra Traffic Guard, SPC beg to lodge a written complaint that on 21.03.2023 around 20:05 hrs I have received information that 01(one) toto vehicle without any registered number is stationed on NH-10, near Uttarayon In Gate, PS-Matigara in such a way blocking the free flow of traffic and causing hindrance to the General public and free flow of others vehicles.

According I ASI Basudeb Banerjee, along with C/273 Sukumar Barman had been to the spot near Uttarayon In Gate, PS-Matigara around 20:05 Hrs and found the above noted toto vehicle along with driver had been stationed in a such a manner disrupting the free flow of traffic, causing hindrance and danger to the General Public and other plying vehicle. On being asked he disclosed his name as Swapan Halder, (Age-45yrs), S/O- Gangacharan Halder of Timulpara, Ward No-04, PS-Siliguri, Dist- Darjeeling.

Further on being asked him to produced relevant documents in support of his claim of plying toto on National Highway, but he failed to produce the same. Hence he committed the cognizable offence disturbing the free flow of vehicular of traffic and endangering the life and free movement of public in general. As such I arrested him u/s 41 Cr.P.C after preparing proper arrest Memo and briefing him about the ground of his arrest in proper way. Thereafter I also seized the toto from his possessions after preparing proper seizure list u/s 102 Cr. P.C in presence of local witness and duly attested by him and took into custody. Hence I would therefore request you to kindly start a specific case under proper section of law against above noted Toto driver and oblige.
