Respected Sir.

- I, Naba Barman, Son of Late Dudha Barman, resident of Matigara, Khudiram Pally, P.O. & P.S. Matigara, Dist. Darjeeling, would like to lodge this written complaint on the following facts:-
- 1) That on 19.03.2023 at about 9:00 a.m. my son namely Sujan Barman went out our house for his meeting /official work purpose that from thereafter we lost connectivity with my son and out of fear we lodge a missing diary to the Matigara Police Station on 20.03.2023.
- That on 21.03.2023 I came to know that my son is detained at patharghata by one Jiban Singha and his other family members. They detained my son with the allegation that my son have a relation with his daughter namely Jiya Roy @ Heera Singha i.e daughter of said Jiban Singha, resident of Patharghata, under Matigara Police Station. Immediately I rushed to the house of Jiya Roy @ Heera Singha and there I found my son is detained by Heera Singha, her father Jiban Singha, her brother Bablu Singha and other family members of Jiya Roy @ Heera Singha and the family members brutally assaulted my son.
- 3) That when I requested them to provide medical assistance to my son and wanted to have a talk with my son but they did not allow me to talk with my son and forcefully blocked my son in a room. Thereafter when I prayed to release my son they demanded for Rs.10,00,000/- by putting me in fare of loss of my son's

life they also threatened if I don't handover the said money to them they will $k\|_I$ my son and implicate entire family in a false criminal case.

- 4) That my son (Sujan Barman's) mobile phone (Samsung) bearing phone No.9547265462 and 7407230298, one Laptop of Dell Company, Gold Chain and money bag bearing 95000/- Cash, all the document Voter Identity Card, Aadhaar Card has been snatched by Jiban Singha, his son, his daughter & others by putting my son in fear in their forceful custody. All these articles are in their wrongful, illegal possession.
- 5) That I came to know that my son and said Jiya Roy @ Heera Singha both are adult and mutually having good friendly relation and Heera Singha introduce herself as Jiya Roy. That my son never consoled the fact that he is a married person and passing his marital life with his wife, family members peacefully.
- 6) That my son told me that the Bablu Singha and said Heera Singha called my son and requested for a meeting in their house and when my son went there they wrongfully, forcefully by betting my son and putting him in a fear of death detained my son under false, misleading allegation and now in such misleading allegation they tried to extort money from me and my son by putting us under the threat of fare of life, reputation and criminal prosecution.
- 7) That my son is detained, heavily physically assaulted by the Singha family under misleading, illegal allegations. In the name of friendly meeting by deceitful manner they induced my son to go their house thereafter they forcefully blocked /detained my son and putting him in fear of death thereafter they informed me about my son's situations by blackmailing me by demanding money.

I, therefore, request you to kindly register a case and investigate the aforesaid matter and take necessary penal steps against the aforesaid culprits Jiban Singha, Bablu Singha, Jiya Roy @ Heera Singha and their other family members for their illegal acts, detention /abduction of my son and demanding money from me and also take remedial steps so that they may not commit any offence further upon my son and my family.
