That today when I enter the office to do my work, one Sri Bikash Ranjan Sarkar, s/o - Lt. Bhasan Sarkar, Resident of South Bharatnagar, P.O - Siliguri Town, Siliguri, Dist - Darjeeling. Rushed into the office and assaulted me with blows and pull down me from my chair. And snatched important documents from me ^{and} my office.
