Sub: First Information Report

Respected Sir/Ma'am,

I, the Branch Head of Church Road Branch, Bank of Baroda, a body corporate constituted under Banking companies (Acquisition and Transfer of Undertaking) Act, 1970 would like to bring to your notice that on Sunday dated 19.03.2023 an incident took place at our Venus more Railway Ticket Booking office off-site ATM connected to our Church Road Branch.

On Monday dated 20.03.2023 our Regional office (IT department) has received a information over whatsapp communication by Shri Manas Dey of M/s AGS India (mob no. 8100472020) that the PC core of the ATM is missing. The said ATM was under CRA cash loading. Our It department immediately called Beat Marshall (Mehabub Alam-7908680558) and he informed us that during the Sutter opening/closing, nothing abnormal was noticed, there is no sign of break open anywhere and back room door is also locked. Our Branch official visited the site on Monday dated 20.03.2023 and informed us that the Machine is shut down but there is no sign of break open anywhere.

On Tuesday dated 21.03.2023 while checking the IVIS portal, we found that some unknown person is opening the ATM Hood on Sunday dated 19.03.2023 around 3.05 pm. It appears that e-surveillance has not functioned during the time of the incident and no alert was triggered from the system.

Reason for Delay:-

On Wednesday dated 22.03.2023 we are able to obtained complete CCTV footage from IVIS from where it evident that a person is opening the Hood of the ATM and stole the PC Core of the ATM. Quotation for the replacement for the stolen part is 87,728/- (eighty seven thousand seven hundred and twenty eight rupees ) excluding taxes.

I'll be highly obliged if you take cognizance of the above stated matter and kindly treat this letter as my official complaint in this regard for registering a criminal case under appropriate provision of law.
