Sub:- Written complaint against 01(one) Driver of plying illegally on Hill Cart Road without any valid documents causing obstruction to public way.

Sir,

I SI, Kedar Pradhan of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 23.03.2023 around 19:45 hrs , while on duty at Hill Cart Road found one (1)TOTO without any registration number stationed near Airview More in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained the said TOTO and on being asked the driver disclosed his identity as Md Hussain, s/o Mahimuddin, Ramganj, Dhologachh, P.S. Islampur, Dist. Uttar Dinajpur. Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they failed to produce the same. Thereafter I seized the said TOTO and arrested the said person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case in terms of Section of 188/283 IPC and other sections of law as deemed fit against the said person with necessary action as applicable.
