However, I had erected 3ft height boundary wall from land level and I was quite sure that my land will not be disturbed at any point of view, and I have directed my witness, Prakash Yadav & Arjun Sharma to look after this boundary, but recently on 01/03/23 when I came to my land, I could see that someone has constructed boundary wall surrounding my land and has been erected over the base which constructed by me. moreover, one pucca tin roofed small room has also constructed attached to the boundary wall. After my personal enquiry in the vicinity I come to know that one Sri Balaram Chhetri Son of Harkha Bhadur Chhetri resident of Rhenock Rungdung near Mata Golai East Sikkim PIN - 737133. has constructed the wall, I tried my best to meet him personally



but he was not available. later I managed to find out his number →  
i.e - 9832683710 and contacted him over phone. As per his version  
he has purchased the land from their relatives smt. Diksha chettri  
of S.K.K.M. wife of Aryan Thapa.

that Sir as a sports person I am unaware and innocent and I have  
purchased the land for residential purpose I have come here to  
construct resident after that I have talk to ~~Arjun~~ Arjun Sharma  
and prakash yadav But very unfortunate they are denying to  
help me actually they are my main witness and they gave  
land document to us as said it is original now I come to  
know that they are cheating us and make unauthentic document  
after meeting with prakash yadav and Arjun Sharma they promise  
to give our land back but they are deny now at current situation  
I come to know that this person were cheating us → and even  
they are witness of one other plot near me which is now  
occur dispute. So, in this regard pls do needfull help as a sports  
person of our nation. by enquiry - my witness - Arjun Sharma of  
milan more / prakash yadav of deridanga - 09439122112

in view of the above I humbly request your honour to take a  
prompt legal action against Arjun Sharma of milan more / prakash  
yadav of deridanga so, that I may construct my residential home  
at my aforesaid land without any disturbance
