Sir,

In producing herewith 01(One) arrested persons namely (1) Akhtar Alam S/O Lt- Naimuddin Alam of Samshi,PS-Samshi dist-Malda A/P-Bagrakote,PS-Siliguri,Dist-Darjeeling.(Paddler of Toto (E-rickshaw), with having number plate no-WB73F7988, blue colour). Along with his Toto under seizer, I SI. Arindam Chatterjee of Junction Traffic Guard, Siliguri Police Commissionerate do here by lodge written complaint against him to the effect that, on 24.03.2023 I along with C-1121 Sushanta Dutta, CV-147 Ashim Sarkar, while performing traffic regulation duty at NH-10, near Apolo crossing found that, the above noted person was plying his Totos (E-rickshaw), as noted above on NH-10 by violating Govt. Order vide **Notification number 1526/1(1)/-WT/3M-56/13/PT.II Dated-27.04.2015 of Principal Secretary to the Govt. of West Bengal** and also disrupting the free flow of traffic by stopping here and there disorderly for collect passengers.


Accordingly, I along with force apprehended him and on asking he could not produce any valid documents nor could able to express any satisfactory reason to do like so. Further asking he stated his name and address as noted above.

Finding no any alternative way I arrested him u/s 41 Cr. P.C and seized his Toto form his possession u/s 102 Cr. P.C by preparing proper arrest memo and seizure list and brought him to Pradhan Nagar Police Station for custody.

I, therefore pray before your kindness that, kindly lodge a specific case in proper section of law against him for violating Govt. order and obstructing for free flow traffic movement and arrange for its proper investigation.
