Sub:- Written complaint against 01(one) Driver of plying illegally on Hill Cart Road without any valid documents causing obstruction to public way.

Sir,

I SI, Samad Ali Mandal of Panitanki Traffic Guard, SPC beg to lodge a written complaint that on 24.03.2023 around 21.05 hrs, while on duty at Hill Cart Road found one (1) TOTO without any registration number stationed near Airview More in such a way blocking the free flow of traffic and causing hindrance and danger to the general public and other vehicles.

Accordingly I detained the said TOTO and on being asked the driver disclosed his identity as Jiban Singha s/o Ram Chandra Singha, Mallaguri, P.S. Pradhan Nagar, Dist. Darjeeling. Further on being asked to produce relevant document in support of their claim of plying TOTO on Major Road they failed to produce the same. Thereafter I seized the said TOTO and arrested the said person under section 41 Cr. PC in c/w the case after observing all rules and formalities.

Therefore I would request you to kindly start a specific case in terms of Section of 188/283 IPC and other sections of law as deemed fit against the said person with necessary action as applicable.
