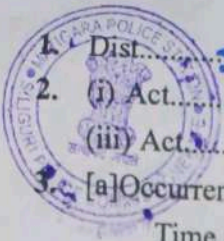

Sir,

I, Gobinda Sarkar, son of Late Maran Sarkar, resident of Patiram Jote, P.O. & P.S. Matigara, District - Darjeeling, Pin Code : 734010, beg to inform you that I am the owner in possession of land measuring 41.67 Decimals situates in L.R. Plot no. 245, recorded in L.R. Khatian No. 245, J.L. No. 77, Pargana - Patharghata, P.S. Matigara, District - Darjeeling by virtue of a registered Deed of Gift being no. 401 for the year 2022 registered at Additional District Sub-Registrar Siliguri - II at Bagdogra and since then I have been peacefully holding, occupying and enjoying the aforesaid land having heritable and transferable right, title and interest thereupon.

That some land grabbers of the locality having muscle power namely (1) Bakul Rani Sikdar, wife of Satish Sikdar, (2) Samir Sikdar, son of Satish Sikdar (3) Tapati Sikdar, wife of Samir Sikdar (4) Sneha Sikdar, daughter of Satish Sikdar and (5) Smriti Sikdar, daughter of Satish Sikdar all are residents of Patiram Jote, P.O. & P.S. Matigara, District - Darjeeling, Pin Code : 734010 for a long time trying to encroach my aforesaid land by various means possible but failed to do so due to the intervention of the local people.

Thereafter on 19/03/2023, at about 9.30 a.m., the said accused persons along with other local miscreants in order to grab my land, they illegally by making criminal conspiracy tried to encroach my below schedule land. Being informed about the same by some local people, I rushed to my land and told them not to do such illegal act. Seeing me, the accused persons became furious and threatened me with filthy languages and also told me that if I

try to stop them, then I shall face dire consequences but the local people gathered therein due to which the Accused Persons finding no other option fled away from the said land and threatened me that I shall face dire consequences and the next time, no one can save me from them if in any way I try to stop them.

It is pertinent to mention herein that the aforesaid Accused Persons have no right, title and interest upon my below scheduled land and they have no right and authority to occupy my land forcibly.

Therefore you are requested to take proper legal action against the said accused persons and other miscreants and allow me to enjoy my land and oblige me.
