Sir,

With due respect I am submitting a written complaint against one accused person namely Pappu Singh (23) s/o Akali Singh of DangiBasty, Tumbajote, PO+PS Matigara, Dist. Darjeeling along with the following seized articles as per proper seizure list:

1. Six Hundred (600) Can Bottles of "Haywards 5000 Premium Strong Beer" each Can Bottle containing 500ml and having MRP Rs 105/- [Total 600x Rs 105/- = Rs 63000/-]
2. Fifty Seven (57) pieces of Plastic Sack.

I, SI Agen Lepcha of Matigara PS would like to lodge a written complaint against the accused person namely Pappu Singh (23) s/o Akali Singh of Dangi Basty, Tumbajote, PO+PS Matigara, Dist. Darjeeling to the effect that today on 23/03/23 at about 18.45 hrs received a source information that the above noted person has stored and concealed huge quantity of liquor illegally inside his house for transporting and selling the same in the state of Bihar for his wrongful gain. This refers to Matigara PS GDE No- 1489, dated 23.03.2023. I informed the matter to O/C Matigara P.S about the information. As per his kind instruction I, along with SI Sajal Roy, SI Sailesh Subba, C/219 Sanatan Chitrakar, and C/1053 Paresch Rava had been to Dangi Basty Tumbajote to work out the information. At 19.25 Hrs we reached at the spot, and called two independent witnesses namely 1] Raj Kumar Roy s/o Late Ram Avatar Roy 2] Dilip Saha s/o Late Laldeb Saha both of Tumbajote, Dangi Basty, PO+PS Matigara, Dist. Darjeeling and shared the information to them. I then called the source to identify the house of said person and being pointed and identified by the source I along with accompanied team entered into the house of said Pappu Singh and soon after seeing the police team he managed to flee away from the spot.

I then along with accompanied team searched his house in presence of witnesses and recovered the above noted seized articles from the house of said Pappu Singh which was kept concealed below the Plastics Sacks inside one room of his house. It is also learnt that he has been engaged in this illegal business since long and used to transport and sell the Liquor illegally in the state of Bihar for his wrongful gain without any valid documents. I seized the above noted articles from the house of said Pappu Singh and took signature of the witnesses. The seizure was made between 19.55Hrs to 20.45Hrs as per proper seizure list.

I, therefore request before your kind honour that a specific case may kindly be started against the accused person namely Pappu Singh (23) s/o Akali Singh of DangiBasty, Tumbajote, PO+PS Matigara, Dist. Darjeeling under proper section of law.
